## HOUSING PROGRAM PRESENTATION

Housing Program Manager Sarah Warren-Riley gave a presentation detailing the City's new housing program. There was a brief discussion regarding plans for continued improvement of the program as well as outreach efforts.

#### 211 SERVICE

Shiawassee United Way Director Retta Parsons gave a presentation on the new 211 service in Shiawassee County. The purpose of the service is to provide a central location for those seeking information on social services in the area.

# STUDENT REPRESENTATIVE REPORT

None. CITIZEN COMMENTS AND QUESTIONS

Shelva Cebulski, 1243 Marion Street, inquired about the annual cost of the 211 service. She also noted the upcoming blood drive at the Knight's of Columbus hall on Wednesday, March  $16^{th}$  from 12:00 – 5:45 p.m.

Burton Fox, 216 East Oliver Street, wished Councilperson Erfourth a happy birthday. He also inquired about the emergency purchase of heating and cooling units for the Public Safety building, saying he was concerned no bids were taken. It was noted the purchase was emergent in nature and 4 quotes were sought from various providers.

Corunna City Manager Joseph Sawyer indicated the City of Corunna is closing on grant funding to improve their water and sewer systems in anticipation of upcoming economic growth, but changes were needed to the water and sewer agreements to allow them to receive the grant. He further noted he was present to answer any questions on the proposed amendments necessitated by the grant.

Brent Jones of the SEDP gave his support to the proposed amendments saying they were essential to allow Corunna to take a proactive approach for economic development.

Justin Horvath, Director of the SEDP, echoed Mr. Jones's comments saying Shiawassee County has very few, if any, vacant industrial buildings and steps must be taken to improve land to allow for further development.

Eddie Urban, 601 Glenwood Avenue, commented on the new 211 service as well as his feelings on the proposed ordinance amendment regarding the discharge of weapons within the City limits.

Thomas Manke, 118 South Washington Street, commented on the proposed water and sewer agreements saying he supports any cooperative efforts between communities in the region. He also encouraged Council to view the community as a part of the greater region when making all decisions.

Councilperson Martenis mentioned he would like to see an aquatic center come to fruition as a regional project. He also asked why the benches on Washington Street do not face the street.

Councilperson Erfourth noted that cupcakes in honor of his birthday were available for anyone that was interested.

Mayor Frederick noted that March is Reading Month and he had greatly enjoyed reading to some local elementary classes. He also noted a recent ceremony honoring two local Eagle Scouts.

Councilperson Cook indicated that in the interest of cooperation he would like to hold a joint council meeting with the City of Corunna. He also encouraged people to contact their legislators regarding the potential cuts to State shared revenue and various tax incentive programs at the State level.

Councilperson Martenis commended the Fire Department for the work they do educating kids.

# CITY MANAGER REPORT

City Manager Donald D. Crawford detailed the proposed ordinance amendment regarding the discharge of weapons in the City saying there were reasonable times a weapon could legally be discharged and a permit process should be put in place to allow things such as archery competitions and shooting ranges as long as specific conditions were met.

#### SETTING A PUBLIC HEARING TO GATHER CITIZEN COMMENT REGARDING THE CLOSURE OF THE ALLEY NORTH OF CLEVELAND AVENUE BETWEEN LAFAYETTE STREET AND HOYT STREET

Whereas, The Owosso City Council has determined it advisable to consider the necessity of vacating, discontinuing, and abolishing the public alley described as follows, to wit:

ALL THAT PART OF ALLEY IN PARK HILL ADDITION TO THE CITY OF OWOSSO, SHIAWASSEE COUNTY, MICHIGAN, RECORDED JULY 30, 1910 IN VOLUME 1 OF PLATS ON PAGE 60 DESCRIBED AS LYING NORTH OF THE NORTH LINE OF CLEVELAND STREET, AND EAST OF LOTS 70-75 AND WEST OF LOTS 106-111

Pursuant to the provisions of Section 29-154 of the 1988 Owosso City Code and Act 288, Public Acts of 1967, as amended, the Owosso City Council does hereby establish 7:30 p.m., Monday, March 21, 2011 in the Owosso City Hall Council Chambers as the time and place to hold a Public Hearing to hear all objections to said proposed alley closure and hereby directs the City Clerk to cause a notice of said Public Hearing to be published in the Owosso Argus Press at least seven days prior to the date of said hearing.

<u>First Reading and Set Public Hearing - Ordinance Amendment</u>. Conduct First Reading and set a public hearing for March 21, 2011 to receive citizen comment regarding proposed ordinance amendment to amend Chapter 19, <u>Nuisances</u>, Article VII, *Offenses Against Public Safety*, Section 19-129, <u>Discharge of Weapons</u>, of the Code of Ordinances of the City of Owosso, Michigan as follows:

# ORDINANCE NO.

ORDINANCE TO MODIFY THE CODE OF ORDINANCES SECTION 19-129 DISCHARGE OF WEAPONS TO ALLOW THE DISCHARGE OF WEAPONS UNDER SUPERVISED SITUATIONS WHEREAS, the city of Owosso has an ordinance regulating the discharge of weapons; and

WHEREAS, the provisions contained in that ordinance prohibit the discharge of weapons in all situations, with no provision for an exception;

THE CITY OF OWOSSO ORDAINS: that Chapter 19, <u>Offenses</u>, Article VII, *Offenses Against Public Safety*, Section 19-129, <u>Discharge of Weapons</u>, be amended as follows:

Section 1: Section 19-129, Discharge of Weapons, be deleted in its entirety.

Section 2: A new Section 19-129, Discharge of Weapons, which reads as follows, be added:

Sec. 19-129. Discharge of weapons.

It shall be unlawful for any person to discharge any firearm, air rifle, air pistol, bow and arrow, sling shot or wrist rocket within the city unless part of an exposition, tournament or range under adult supervision after issuance of a permit by the police department.

Section 3. Repeal Clause.

All ordinances in conflict with this ordinance are hereby repealed to the extent of the conflict.

Section 4. Severability.

If any section, subsection, sentence, clause, phrase or portion of this amendment for any reason is held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions hereof.

Section 5. Effective Date.

This ordinance shall take effect 20 days after its passage.

Section 6. Inspection.

This Ordinance may be purchased or inspected in the City Clerk's Office Monday through Friday between the hours of 9:00 a.m. and 5:00 p.m.

<u>Emergency Purchase Authorization</u>. Authorize emergency purchase and installation of heating and air-conditioning units for the Public Safety Building from Lamphere's Plumbing and Heating in the amount of \$10,837.00 as follows:

# **RESOLUTION NO. 41-2011**

#### RESOLUTION AUTHORIZING EMERGENCY PURCHASE AND INSTALLATION OF TWO ROOF TOP HEATING AND AIR-CONDITIONING UNITS

WHEREAS, the City of Owosso, Shiawassee County, Michigan, has a public safety building that requires heat and air conditioning.

WHEREAS, the City of Owosso discovered that two roof top heating and air-conditioning units had cracks in the heat exchangers that could emit carbon-monoxide into the building that required immediate attention.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Owosso, Shiawassee County, Michigan that:

- FIRST: The City of Owosso has theretofore determined that an emergency required the immediate purchase of the heating and air-conditioning units.

#### RESOLUTION AUTHORIZING THE EXECUTION OF AN ADDENDUM TO WATER AGREEMENT BETWEEN THE CITY OF OWOSSO AND THE CITY OF CORUNNA

WHEREAS, the city of Owosso and the city of Corunna entered into an agreement for the sale and purchase of water dated June 17, 1991and amended in February of 1993;

WHEREAS, the city of Corunna applied for a United States Department of Agriculture Rural Development loan requiring amendments to the June 17, 1991 agreement in order for the loan to be closed, which include the inclusion of the following provisions:

- 1. The term of this agreement shall be 42 years from the date of execution of this amendment.
- 2. This agreement is fully assignable, whether such assignment occurs by reason of legal process, written assignment or otherwise.
- 3. This agreement shall inure to the benefit of and be binding upon the respective parties hereto and both the successors and assigns of the respective parties.
- 4. In the event that there is a reduction in the city of Owosso's ability to provide water, all the users of the city of Owosso's water supply operation shall proportionately in the reduction of the city's water ability.

WHEREAS, an addendum to the water agreement between the city of Owosso and the city of Corunna has been prepared and is attached to this resolution;

NOW THEREFORE BE IT RESOLVED by the city council of the city of Owosso, Shiawassee County, Michigan that:

- FIRST: the city of Owosso has heretofore determined that it is advisable, necessary and in the public interest to amend an agreement titled *Water Agreement* and dated June 17, 1991 as amended between the city of Owosso and the city of Corunna.
- SECOND: the city council approves and the mayor and city clerk are instructed and authorized to execute for and on behalf of the city of Owosso an agreement substantially in the form the attached exhibit, *Addendum to the Water Agreement Between the City of Owosso and the City of Corunna.*
- THIRD: the city clerk is authorized and directed to attest to the signature of the mayor and other city officials on said agreement and retain in the city clerk's office a fully executed original of said agreement for public inspection.

## ADDENDUM TO WATER AGREEMENT BETWEEN THE CITY OF OWOSSO AND THE CITY OF CORUNNA

This Agreement, entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2011 by and between the CITY OF OWOSSO, a municipal corporation, hereinafter referred to as the "Seller", and the CITY OF CORUNNA, a municipal corporation, hereafter referred to as the "Buyer",

WITNESSETH as follows:

WHEREAS, the parties entered into an agreement for the sale and purchase of water by means of a Contract dated June  $17^{th}$ , 1991;

WHEREAS, it is the desire of the City of Corunna to extend the terms of the contract;

NOW, THEREFORE, IT IS HEREBY AGREED, by and between the parties hereto as follows, to-wit:

- 1. That Section 17 (page 13) shall be amended to read: 'The term of this agreement shall be 42 years from the date of execution of this amendment".
- 2. The following language shall be added to Section 18 (page 14) "This agreement is fully assignable, whether such assignment occurs by reason of legal process, written
  - assignment or otherwise."
- 3. That Section 19 (page 14) shall be amended to read: "This agreement shall inure to the benefit of and be binding upon the respective parties hereto and both the successors and assigns of the respective parties".
- 4. The following provision is added to the contract, "In the event that there is a reduction in the City of Owosso's ability to provide water, all the users of the City of Owosso's water supply operation shall share proportionately in the reduction of the city's water ability.

It is further agreed that all other provisions of the contract dated June 17<sup>th</sup>, 1991 shall remain in full force and effect.

WHEREAS, an addendum to the sewer service agreement between the city of Owosso, the city of Corunna, and the charter townships of Caledonia and Owosso has been prepared and is attached to this resolution;

NOW THEREFORE BE IT RESOLVED by the city council of the city of Owosso, Shiawassee County, Michigan that:

FIRST: the city of Owosso has heretofore determined that it is advisable, necessary and in the public interest to amend an agreement titled Agreement Between the City of Owosso, the City of Corunna, and the Townships of Caledonia *and Owosso* dated August 17, 1977 and amended December 20, 2004 between the city of Owosso, the city of Corunna, and the charter townships of Caledonia and Owosso.

- SECOND: the city council approves and the mayor and city clerk are instructed and authorized to execute for and on behalf of the city of Owosso an agreement substantially in the form the attached exhibit, *Addendum to Sewer Service Agreement Between the City of Owosso, the City of Corunna, and the Charter Townships of Owosso and Caledonia.*

WHEREAS, the parties entered into an AGREEMENT dated August 17, 1977 for sewer service to be provided by the City of Owosso for the City of Corunna and the Charter Townships of Caledonia and Owosso; and which Contract was amended on December 20<sup>th</sup>, 2004;

WHEREAS, it is the desire of the City of Corunna to amend the terms of the contract;

NOW, THEREFORE, IT IS HEREBY AGREED, by and between the parties hereto as follows, to-wit:

- 1. The following language shall be added to Section 15 (page 31) of the agreement: The agreement shall remain in full force and effect for a minimum of forty-two (42) years from and after the date of execution of this agreement.
- 2. The following language shall be added to Section 7 (page 24): This Agreement is fully assignable by either parties to this agreement, whether such assignment occurs by reason of legal process, written assignment or otherwise.
- The following language shall be added to the agreement: "In the event that there is a reduction in the City of Owosso's ability to provide sewer service, all the users of the City of Owosso's sewer treatment operation shall share proportionately in

the City of Owosso's sewer treatment operation shall share proportionately in the reduction of the city's sewer treatment ability.

It is further agreed that all other provisions of the contract dated August 17<sup>th</sup>, 1977, and the Amendment to the Sewer Service Agreement dated December 20<sup>lh</sup>, 2004, shall remain in full force and effect.
