A public hearing was held to receive citizen comment regarding request to close the public alley east of lots 70-75 and west of lots 106-111, Park Hill Addition, City of Owosso, Shiawassee County, Michigan (north of Cleveland Avenue and parallel to Lafayette Street)

There were no citizen comments.

Staff reported in a written report to City Council that the Planning Commission had held a public hearing and voted to recommend the closure of the alley.

ORDINANCE AMENDMENT – DISCHARGE OF WEAPONS

A public hearing was conducted to receive citizen comment regarding proposed ordinance to amend Chapter 19, <u>Nuisances</u>, Article VII, *Offenses Against Public Safety*, Section 19-129, <u>Discharge of Weapons</u>, of the Code of Ordinances of the City of Owosso, Michigan.

There were no citizen comments.

Motion by Councilperson Cook to authorize the following amendment to Chapter 19, <u>Nuisances</u>, Article VII, *Offenses Against Public Safety*, Section 19-129, <u>Discharge of Weapons</u>, of the Code of Ordinances of the City of Owosso, Michigan.

ORDINANCE NO. 720

ORDINANCE TO MODIFY THE CODE OF ORDINANCES SECTION 19-129 DISCHARGE OF WEAPONS TO ALLOW THE DISCHARGE OF WEAPONS UNDER SUPERVISED SITUATIONS

WHEREAS, the city of Owosso has an ordinance regulating the discharge of weapons; and

WHEREAS, the provisions contained in that ordinance prohibit the discharge of weapons in all situations, with no provision for an exception;

THE CITY OF OWOSSO ORDAINS: that Chapter 19, <u>Nuisances</u>, Article VII, Offenses Against Public Safety, Section 19-129, <u>Discharge of Weapons</u>, be amended as follows:

Section 1: Section 19-129, Discharge of Weapons, be deleted in its entirety.

Section 2: A new Section 19-129, <u>Discharge of Weapons</u>, which reads as follows, be added:

Sec. 19-129. Discharge of weapons.

It shall be unlawful for any person to discharge any firearm, air rifle, air pistol, bow and arrow, sling shot or wrist rocket within the city unless part of an exposition, tournament or range under adult supervision after issuance of a permit by the police department.

Section 3. Repeal Clause.

All ordinances in conflict with this ordinance are hereby repealed to the extent of the conflict.

Section 4. Severability.

If any section, subsection, sentence, clause, phrase or portion of this amendment for any reason is held invalid or unconstitutional by any court of competent jurisdiction, such portion

shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions hereof.

Section 5. Effective Date.

This ordinance shall take effect April 10, 2011.

Section 6. Inspection.

This Ordinance may be purchased or inspected in the City Clerk's Office Monday through Friday between the hours of 9:00 a.m. and 5:00 p.m.

Specific topics of comment included: concern for the children and other users of St. Paul facilities, concerns regarding crime associated with marijuana businesses, potential illegal activities taking place at the facility, establishing zoning policies to prohibit a medical marijuana related facility within 1000' of a school or church, closing the facility down, and why a moratorium on medical marijuana related facilities was not enacted.

Burton Fox, Planning Commission Chairman, detailed the process the medical marijuana issue has taken over the course of the last year. He went on to say he felt the current establishment could be moved.

The 30-minute time limit was reached.

There was discussion regarding the "1000' rule", whether federal law supersedes state law, why Council did not enact a moratorium, why it has taken so long to address this issue, the effectiveness of a moratorium given the City does not license businesses, complaints surrounding such facilities, and ways of regulating medical marijuana facilities. It was noted the County Prosecutor had declared the "1000' rule" not applicable to medical marijuana facilities. City Attorney Brown expressed a desire to speak with the County Prosecutor regarding his opinion to determine whether he felt state law superseded federal law in this case.

Motion by Councilperson Cook to instruct the City Attorney to contact the County Prosecutor for further information regarding his opinion on the "1000' rule".

City Manager Donald D. Crawford detailed an insurance scam that has been circulating in the area saying the coverage was not worth the premiums.

He went on to discuss the Governor's recent mandates and how they might affect the City. He noted it is still difficult to spell out just how the mandates will affect things he felt the City will not receive as much state shared revenue as they have in the past even if they comply with all of the new regulations put forth by the Governor.
