

**NOTICE OF PROJECT PLAN PUBLIC HEARING**  
**City of Owosso Lead Service Line Replacement**

The City of Owosso will hold a public hearing on the proposed funded project to replace community water service lines constructed of lead or galvanized metal, for the purpose of receiving comments from interested persons.

The hearing will be held in the City Hall Council Chambers, 301 West Main Street, Owosso at 7:30 p.m. on Monday, June 28, 2021. You must be present or submit your comments in writing to participate in the hearing.

The purpose of the proposed project is to comply with the state of Michigan Lead and Copper Rules and the Michigan Clean Water Act.

The city of Owosso submitted an application for and has been recently approved to receive qualifying funding up to the maximum allowed of \$3.0 million dollars from the state of Michigan Department of Environment Great Lakes & Energy (EGLE), for its proposed lead service line project plan. All water service line replacement construction costs are eligible for 100% reimbursement, as the city of Owosso has obtained disadvantaged community status in accordance with EGLE guidelines.

Proposed project plan replaces water service lines from the water main to the building premises that are constructed of lead or galvanized material, and at no cost to the property owners.

Impacts of the proposed project include temporary noise and dust associated with construction projects, as well as temporary interrupted water service pending reconnection of new service lines. The improvements should not cause measurable long term detrimental environmental impacts.
