## **OPERATIONS AND COMMUNITY RELATIONS**

- Leaf Pickup Fall 2020: This year's leaf pickup will start November 25. Flyer will be mailed with quarterly utility bills to inform residents. Flyer includes information on the pickup, suggestions, and a map of pickups with corresponding schedules for specific areas.
- Matthews Building Code Enforcement: Court trial process restarted after owners did not sign dismissal agreement. City proposal to assess building and recommend options for remediation is ready to be signed the week of Oct 5. Owners are now trying to submit a plan to remove debris and replace the roof and building support structure because they claim it would cost less and take less time. Staff is working with the owners but have begun the process to solve the problem without them.
- Trick or Treat 2020: The city cannot prevent trick or treating and does not plan to try. Trick or treating is not a citysanctioned event. The city just sets a recommended schedule to follow on Oct 31. CDC and local health department guidance highly encouraged due to COVID.
- JC Penney Building: Staff met with building owner and city planner to discuss how the city can help fill the space. Owner has a plan in place.
- CARES Grants
  - **First Responder Payroll Reimbursement Grant:** 50% has been approved and deposited in city's bank account (\$240,000). The fate of the over 50% is TBD. The state received many more applications than expected.
  - **First Responder Hazard Pay Grant:** \$36,000 was paid to eligible employees (\$1000 each) in late August and the City was awarded 100% reimbursement.
- **Historical Plaque Cleaning:** Local history buffs volunteered to clean and polish some of the historical plaques around town. Some residents called to ask about the green substance used to clean the years of paint, lacquer and dirt from the plaques. This substance was a mixture of flour, salt, and vinegar. The plaques were then polished with some needing more than others. A substance will be applied to create some contrast so the letters can be easily read and to restore the plaques' appearance. This was volunteer driven with the city's permission.
- **Apartment Available:** One of the apartments at the Gould House is available for rent. Contact Amy Fuller at the City for more information.
- New State Budget: The latest draft of the state's budget does not include a reduction in revenue sharing. The city budgeted a 20% reduction this year but right now it looks like we may only see a 2% reduction mostly from constitutional revenue sharing. Statutory will be held the same as last year. This is good news but until the economy comes back 100% we need to be vigilant with finances.
- **Property Tax Collection During COVID:** The City Treasurer reports that summer collection delinquencies this year are much lower than summer 2019. Some of this may have had to do with the unemployment boost and federal COVID stimulus checks.
- Michigan State of Emergency Extension: The Governor has extended Michigan's COVID state of emergency to October 27, 2020. For the past 2 months, Governor Whitmer has been extending the state of emergency month to month.
- **2020 General Election:** The city clerk's office still needs poll workers!! So far 2600 absentee ballots have been submitted and there could be more between now and election day. This is a large increase from the 2018 election when only 1900 absentee ballots were submitted.
