

**NOTICE TO BIDDERS
HINTZ WELL-FIELD REHABILITATION
NEW MUNICIPAL PRODUCTION WELL BID PROPOSAL
FOR THE CITY OF OWOSSO, MI**

The City of Owosso is seeking a qualified State of Michigan licensed Type I Water Supply Contractor, to provide a hydrogeology study, aquifer test, identification of proposed Standard Isolation Area, drilling services, chemical analysis of water from test wells, site plan with location of proposed production wells, and detailed construction specifications for the proposed production wells. In addition, the existing Hintz Road production well no longer in operation, shall be plugged and abandoned. Further, recommendations for well house construction shall be submitted. Finally, detailed specifications for distribution piping shall be developed for connection to existing raw water lines.

Bids will be accepted until **2:00 p.m., SEPTEMBER 19, 2017** for the **HINTZ WELL REPLACEMENT** at which time bids will be publicly opened and read aloud.

All bids must be in writing and must contain an original signature by an authorized officer of the firm. Electronic bids (i.e., telephonic, fax, email, etc.) are **NOT** acceptable.

At the time the contract is executed, the contractor shall file a bond to the city executed by a surety company authorized to do business in the state, conditioned upon the performance of said contract, and further conditioned to pay all laborers, mechanics, subcontractors and material suppliers as well as all just debts, dues and demands incurred in the performance of such work. The contractor shall also file evidence of public liability insurance and workers compensation in an amount satisfactory to the city attorney, and agree to hold the harmless from loss of damage caused to any person or property by reason of the contractor's negligence.

All bids shall clearly contain on the outside of the **sealed** envelope in which they are submitted:

All work is to be completed by June 30, 2018 or as agreed upon by proposed contractor.
