

**NOTICE TO BIDDERS  
SANITARY AND STORM SEWER REHABILITATION BID

Sealed proposals will be received by the city of Owosso for the **SANITARY AND STORM SEWER REHABILITATION BID** and should be addressed to:

**Major items include:** All construction improvements and materials for sanitary and storm sewer repairs as shown in the drawings and related provisions provided herein.

Bids will be accepted until **Tuesday, January 8 at 3:00pm** for the **SANITARY AND STORM SEWER REHABILITATION BID** at which time bids will be publicly opened and read aloud.

All bids must be in writing and must contain an original signature by an authorized officer of the firm. Electronic bids (i.e., telephonic, fax, email, etc.) are **NOT** acceptable.

**Bid must be accompanied by bid security made payable to Owner in an amount of 5% of Bidder's maximum bid price (determined by adding the base bid and all alternates) in the form of a certified check, bank money order, or a Bid Bond.**

The bidder agrees that if the city accepts their proposal, the bidder will, within 10 consecutive calendar days after receiving notice of this acceptance, enter into a contract to furnish all labor, equipment and tools necessary to execute the work at the unit prices named in the bid proposal and will furnish the surety for performance, for one hundred percent (100%) of this bid, which shall be accepted and approved by the city.

All bids shall clearly contain on the outside of the **sealed** envelope in which they are submitted:

**SANITARY AND STORM SEWER REHABILITATION BID**

**No work can begin before January 28, 2019 and all work shall be completed according to the following schedule:**

- Williams and Seventh Street – April 1, 2019
- Washington and Ridge Street – May 15, 2019
- All other Streets – June 7, 2019
