	STATE LEGISLATIVE UPDATE				
Pension Funding Grant Program	In 2022, the state legislature was considering creating a grant fund to help cities pay down their unfunded liabilities with pensions. \$750 million was going to be allocated for cities that were below 60% funded and \$250 million was for cities over 60% funded. The \$750 million was kept but the \$250 million was eliminated. So only municipalities (cities, counties, villages) with a sub- 60% funded ratio are eligible. Owosso is 95% funded.	State budget does not include this funding. State has denied the request.			
Curbside Recycling Required by 2028	Passed in December of 2022, this legislation amended PA 451 of 1994 – specifically Part 115 – to mandate that all cities over a population of 5000 shall be required to have curbside recycling established with at least 90% of single family households within the city by January of 2028.
