WHEREAS, this property is located in the city limits of the City of Owosso, County of Shiawassee; and


WHEREAS, the property description of proposed district is:

RE: Tax Abatement Application – Owosso Composite, LLC. 403 S. State St.

On Monday April, 9, 2012, city clerk received an application for a Tax Abatement for a Personal Property IFT at 403 S. State Street. This manufacturing facility has operated under the name of DMM Industries for many years, maker of paddle boats and fiberglass components. The property is being leased by Owosso Composites, LLC, in connection with Crest Marine, South M-52 and Delaney Roads. Initial Review indicates the applicant meets the requirements for tax abatement, except there is no Development District or Rehab District in place at this property.

With that in mind, we are asking council to set a public hearing on Monday, April 30, 2012 for the purpose of establishing an Industrial Development District at 403 S. State Street, described as:

LOTS 8 & 9 AND EAST 9 FEET OF LOT 7, BLOCK 2. ALSO, OUTLOT 1 & NORTH 61 FEET OF OUTLOT 2. GEORGE THOMAS ADDITION TO CITY OF OWOSSO (EXCEPT ROALROAD RIGHT OF WAY)

Once said district is established, the council will address the application for an Industrial Facilities Tax Exemption Certificate. As a reminder, Act 198 of 1974, is a tax abatement which reduces the tax burden by 50%. The applicant is applying for the IFT exemption on new personal property only. This exemption can be granted for up to 12 years.

The city clerk has notified the taxing jurisdictions of this application as required under the city's abatement policy and as required under the act and will forward any responses to you





January 13, 2012 Frank Fisher from Fisher Sand and Gravel stopped at my office and advised me that he concerns about the owners of Smith Sand and Gravel who are razing the house at 117 S. Shiawassee at the city of Owosso's request. Fisher advised he followed the trucks of debris when it left the site at 117 S. Shiawassee and the debris was not taken to a land fill. Fisher said he followed several loads to Smiths Sand and Gravel on Tyrell Rd. and the truck entered the property and left empty. I advised Fisher that the owner of Smith Sand and Gravel had disclosed that he had intended on salvaging the brick from the home that was demolished. Fisher advised what he witnessed was not brick. Fisher advised he had contacted a friend at the DEQ for this matter to be looked into.

On January 16, 2012 Fisher again came to my office and provided me with copies of Inbound-Charge Tickets from Brent Run Landfill for demo's his company had completed so I could use them as a reference with Smith Sand and Gravel Inbound-Charge Tickets for the demo at 117 S. Shiawassee St. I advised Fisher that I would be calling the DEQ with his complaint and asked if he was willing to be a witness if the DEQ was going to investigate. Fisher declined stating he wanted to talk to his friend at the DEQ.

On January 16, 2012 Travis Smith from Smith Sand and Gravel called and said the project was almost complete at that he had 3 loads that he had not yet delivered to the land fill because of bad weather on Friday January 13, 2012.

On January 17, 2012 I called the DEQ and spike with Duane Reskowskey 1-517-373-4712. I apprised Reskowskey of the information I had received. He advised that to the DQE this was of low priority and that they would not respond and advised the it could be investigated by the local authorities but from his experience locals typically got little results from prosecution. Reskowskey gave me the number of the DEQ that worked the Shiawassee County area Bethel Skinner. I called Skinner 517-335-6127 and she referred me to Brian Groechowski I talked with him and he agreed with Reskowskey and suggested that I talk with owners of Smith Sand and Gravel and put them on notice that this was not acceptable if it was happening and possibly notify the county official to a ticket to be issued if this turned out to be true.

On January 18, 2012 Frank Fisher again came to see me and said he had contacted the DEQ and they will be in town on Thursday and was going to sop and see me. Fisher said that the official from DEQ is Eric Vanriper.

On January 18, 2012 I got a call from Dave Chrenka Shiawassee County code enforcement. Chernka inquired about what information I had and advised they there have been problems with Smith Sand and Gravel and I might investigate the property on Tyrell Rd and get some pictures. I asked Chrenka where he got his info from and he did not say but mentioned other are in this business and made mention of Fisher.

On January 18, 2012 I called Smith Sand and Gravel and asked that they supply there Charge Ticket for the demo at 117 S Shiawassee. Shirley Smith immediately said that Fisher has been following them and causing them problems because Fisher bid on the


demo and did not get it. Smith faxed me the Tickets and are in my file. Travis Smith later called and said he still has three loads that need to go to the land fill that he will likely take before the end of the week.

On January 19 Dave Chrenka called me and advised that he examined the site and photographed the site and talked with Travis Smith. Chrenka said he found about 2-3 loads of debris from the demo site dumped at Smith Sand and Gravel and Travis Smith admitted this. Smith said that he intended to take this to the land fill. Chrenka sent a copy of his photo to me I find it difficult to believe that Smith had any intention of taking the debris to the land fill had not the county code inspector or myself looking into this matter. The debris appears to me to me to be dumped in a hole, if this debris was intended to be moved it would have been put on a flat surface so it could be easily loaded. Chrenka advised that Smith said he would have this debris to the land fill by January 14, 2012. Chrenka will keep me updated on the progress.








#### **GRAND AVENUE**

(Auburndale to 267' N. of Auburndale) 95% of all distresses are located.

PCI Value: 10

This section has poor drainage, with curb and gutter having 2"-4" in height, and should be milled and overlayed or reconstructed

(267' N. of Auburndale to Franklin) One full depth patch approximately 20'x10' would be advised, due to the medium/high severity alligator cracking. This portion needs watermain. *PCI Value:* 90

This section has poor drainage, with curb and gutter having 2"-4" in height, and has been recently slurry sealed. No major rehabilitation (no overlay or reconstruction) is required during the next five years.

#### STATE STREET (MAIN STREET TO SOUTH END) AND ALLEY AND PARKING LOT)

From Main to Lynn, section has poor drainage with curb and gutter ranging from 2" to 4" in height. Total reconstruction or mill, full depth patching and AC overlay from Lynn to South End, one lane reconstruction or mill and overlay. The other lane (from South End to Lynn) looks good. *PCI VALUE:* 0

However, if it is economical to rehabilitate one lane then both lanes should be rehabilitated at the same time.

#### NORTH HICKORY STREET (EXCHANGE TO OLIVER)

This section has poor drainage with a curb and gutter having less than 2" in height. Mill and overlay or total reconstruction.

PCI VALUE: 0

#### KENWOOD DRIVE (FREDERICK TO FREEMAN)

Residents have petitioned for this assessment. Main distress is medium severity edge cracking. Full depth patches recommended, no overlay required at this time. This section has no curb & gutter, and poor drainage. This section is triple seal coated. There is a limitation on the change of existing road elevation. This street needs new watermain. Reconstruct: recycle existing material and remove organic soil.

PCI VALUE: 50

#### **GRACE STREET**

Residents have petitioned for this assessment. 98% of distress's has to do with the medium/high severity edge cracking. Full depth patches recommended. No overlay required at this time. Poor drainage. The adjacent property owners want curb and gutter. The pavement in this section is triple seal coated over gravel. There is a limitation on the change of existing road elevation. Reconstruct: recycle existing material and remove organic soil. This street needs new watermain.

PCI VALUE: 65

#### **SOUTH CHIPMAN (MAIN TO LYNN)**

This section has poor drainage with a curb and gutter ranging from 0" to 6" in height. Full depth patches recommended at the locations of high alligator and edge cracking. Mill and overlay recommended.

#### **NORTH CHIPMAN**

#### (BEEHLER TO 719' N. OF BEEHLER)

This section has good drainage with a curb and gutter ranging from 4" to 6" in height. Microsurfacing is coming off. Mill and overlay is recommended.

#### (719' N. OF BEEHLER TO OLIVER)

This section has good drainage with a curb and gutter having 4"-6" in height. Routine maintenance is recommended (crack filling and patching). No need to overlay during the next five years.

#### (OLIVER TO WILLOW SPRINGS)

This section has good drainage with a curb and gutter having 4"-6" in height. This section should be divided into two sections. Oliver to W. King should be milled and overlayed. W. King to Willow Springs does not need major rehabilitation during the next five years.

#### (WILLOW SPRINGS TO HARDING)

Crack filling medium to high severity longitudinal and transverse cracks, and full depth patches at the **locations of high severity edge cracking is recommended**. This section has good drainage, and curb and gutter. No need to overlay during the next five years.

#### **OLIVER AND GOULD INTERSECTION**

Make full-depth patches, mill and overlay.

#### **OLIVER STREET EAST OF BRIDGE**

Route, seal and micro-surface,
