#### ALLEY CLOSURE - SOUTH OF GRACE BETWEEN PEARCE AND CEDAR STREETS

A public hearing was conducted to receive citizen comment regarding request to close Public alley south of the south line of Grace Street, east of Lots 1-8 and west of Lots 83-90, Grand View Addition, City of Owosso, Shiawassee County, Michigan.

Sally Bishop, 1028 Pearce Street, indicated she had initiated the petition and supported the closing of the alley. She had questions regarding how the property would be split, notification of the closure, the placement of burning barrels, and whether or the not the City would be surveying the property. It was noted the City would not be surveying the property and such services would have to be undertaken by individual property owners. Council also asked that all the adjoining property owners be notified of the closure.

WHEREAS, city staff has found no issues with the petition and has recommended approval of the alley abandonment; and

WHEREAS, the planning commission held a public hearing on July 25, 2011 and subsequently recommended abandonment of the alley; and

WHEREAS, the City Council of the City of Owosso, Michigan, in accordance with city ordinance Section 29-154, has met at the time and place named in a resolution passed by said City Council at a meeting thereof held on August 1, 2011 and in accordance to notice thereof published by the City Clerk in The Owosso Argus Press, for the purpose of hearing and considering objections to the proposed vacation and discontinuance of the following portions of public alley in said City, and all objections of such proposed action having been heard and duly considered in a public meeting held on August 15, 2011;

NOW THEREFORE BE IT RESOLVED that for the benefit of the public health and welfare and safety of persons and property within the City of Owosso, County of Shiawassee, State of Michigan, be and the same is hereby vacated, discontinued and abolished, said portions of said alley being more particularly described as follows, to wit:

#### **OBSOLETE PROPERTY REHABILITATION EXEMPTION CERTIFICATE – WESENER, LLC**

A Public Hearing was conducted to receive citizen comments regarding application from Wesener, LLC for an Obsolete Property Rehabilitation Exemption Certificate for their property at 104-108 North Washington Street.

Philip Hathaway, Town Plans, LLC, spoke on behalf of the applicant indicating the importance of this exemption to the overall project and the reason behind asking for a lesser abatement than they are eligible for.

Motion by Councilperson Erfourth to approve the following resolution authorizing an Obsolete Property Rehabilitation Exemption for the property owned by Wesener, LLC at 104-108 North Washington Street for a period of 6 years:

# A RESOLUTION TO APPROVE THE APPLICATION FOR AN OBSOLETE PROPERTY REHABILITATION EXEMPTION CERTIFICATE FROM DAVE ACTON OF WESENER, LLC FOR PROPERTY LOCATED AT 104–108 N. WASHINGTON STREET

WHEREAS, the City of Owosso is a Qualified Local Government Unit within the State of Michigan and is empowered to provide tax exemptions for increased value of rehabilitated facilities within the City; and

WHEREAS, after public notice and a public hearing on March 1, 2004, the City Council of the City of Owosso approved an Obsolete Property Rehabilitation District at 104-108 N. Washington Street in Owosso, Michigan at said meeting, as provided by section 4(2) of Public Act 146 of 2000. Said property more particularly described as:

S 2/3 OF LOT 5 & N 1/3 OF LOT 6 (EX E 22' OF LOT 6) BLK 21 ORIGINAL PLAT

WHEREAS, the City Clerk received a complete application and required documentation on July 27, 2011 from Dave Acton, authorized agent for Wesener, LLC, owner of the property, for an Obsolete Property Rehabilitation Exemption Certificate requesting a 6 year abatement; and

WHEREAS, notice of a public hearing concerning the application for an exemption certificate was provided to the Assessor of the City and the legislative body of each taxing unit that levies ad valorem property taxes in the City; and

WHEREAS, the City finds that the property meets the definition of an obsolete property as defined in section 2(h) of Public Act 146 of 2000 and the application for the exemption certificate is complete; and

WHEREAS, the City finds that the property relates to a rehabilitation program that when completed constitutes a "rehabilitated facility" within the meaning of P.A. 146 of 2000, and said property is located within an Obsolete Property Rehabilitation District established in a Qualified Local Governmental Unit eligible under Public Act 146 of 2000 to establish such a district; and

WHEREAS, the rehabilitation includes improvements aggregating 10% or more of the true cash value of the property at commencement of the rehabilitation as provided by section 2(I) of PA 146 of 2000; and

WHEREAS, it has been found that the rehabilitation of the obsolete property is calculated to, and will at the time of the issuance of the certificate, have the reasonable likelihood to increase commercial activity, retain and create employment, and revitalize the downtown; and

WHEREAS, the taxable value of the property proposed to be exempt plus the aggregate taxable value of the property already exempt under PA 146 of 2000 and under PA 198 of 1974 does not exceed 5% of the total taxable value of the unit; and

WHEREAS, the applicant is not delinquent in any taxes related to the facility; and

WHEREAS, the rehabilitation work described in the application had not commenced prior to the establishment of the District.

NOW, THEREFORE, BE IT RESOLVED that, based on the findings above made at public hearing, the City Council of the City of Owosso authorizes the application for an Obsolete Property Rehabilitation Exemption Certificate at 104-108 N. Washington Street for a period of 6 years as requested by the applicant; and

ALSO, BE IT RESOLVED that the rehabilitation shall be completed within eighteen (18) months from the date of approval of said application, and

FURTHERMORE, BE IT RESOLVED that the application and resolution are authorized for submittal to the State Tax Commission for final review and authorization.

#### **CITIZEN COMMENTS AND QUESTIONS**

Gary Ballenger, 806 South Saginaw Street, indicated he feels the City should purchase a second street sweeper as one cannot keep all of the streets clean. He also asked that the storm drains in his area be checked as the street floods when it rains hard.

Shelva Cebulski, 1243 Marion Street, indicated she doesn't feel the City needs another street sweeper but rather needs better enforcement of the ordinance that prohibits citizens from sweeping grass clippings into the street. She also announced the Battle of the Badges blood drive to be held August 24<sup>th</sup> from noon to 5:45 p.m. at the Knights of Columbus hall.

Councilperson Erfourth thanked everyone that participated in the painting event last weekend. Despite the rain they were able to accomplish a lot.

Councilperson Martenis indicated he had received calls about debris in the street in the past and the problem had been noted. He also encouraged citizens to help with the problem of dirty streets by ensuring their lawn clippings are kept out of the street.

Councilperson Cook inquired what was being done around the City in regard to erosion control, noting some specific areas that have seen significant erosion recently. It was noted there are requirements in place for erosion control though many of the projects are not subject to the requirements because they are too small.

Mayor Pro-Tem Popovitch announced a fund raiser at the hospital on August 26<sup>th</sup> to raise money for free cancer screenings.

#### **CITY MANAGER REPORT**

Assistant City Manager Adam H. Zettel handed the floor over to Finance Director Richard C. Williams to provide detail on the 2011 Citizen's Guide to City of Owosso Financial Health Report as well as the Dashboard Report, both required by the State as part of the new revenue sharing program. Mr. Williams noted that the City is in good shape financially but services have been reduced to keep in line with declining revenues. He also noted that his chief point of concern was the aging infrastructure of the City, while it is in decent shape currently significant investment will be needed in the future to ensure the City is able to continue to provide a quality infrastructure.

There was discussion regarding using the reports during the budget planning process, obtaining actual figures in place of the graph representations, and following the State's requirements in the assembly of the reports.

Mayor Frederick indicated he was proud of the fiscal prudence the City has shown over the years.

#### **CITIZEN COMMENTS AND QUESTIONS**

Tom Manke, 118 South Washington Street, indicated he was pleased the City was having a discussion about the website because improvements need to be made. He also encouraged the City to utilize social media outlets and put a person in place to manage the sites.

Ronald Elder, County Commissioner District 2, noted the County now has a new website that is working well. He also noted that August starts budget planning time at the County and a budget is to be in place by November.

Mayor Pro-Tem Popovitch inquired about the Main Street manager situation. It was noted the City no longer had a Main Street manager and is in the process of looking for one.

#### **DISCUSSION** – CITY WEBSITE

City Manager Crawford started the conversation with a history of the City's website, noting that spending on the website has been low in comparison with other communities. The City is now at a point where money will need to be spent to improve the site.

He listed the following items as potential improvements for the website:

Expand screen size
Include more links to outside websites
Include more basic City related information
Provide the opportunity for live broadcast and video on demand services
Develop new menus and drop downs

Mr. Crawford introduced Curt Anderson and Laura Hoffman of Municipal Web Services, joining the meeting via the internet. Municipal Web is the City's current web designer/host.

Mr. Anderson indicated numerous features of websites have changed in the past few years. He noted that any wholesale changes to the site would necessitate redoing the entire site as the software originally used to develop the site was no longer supported. He went on to say that should the Council decide to revamp the website decisions would have to be made as to the format of the home page, whether the site would be edited via website management software or content management software and whether the City desired custom programs for the site. In addition decisions would have to be made regarding color scheme and general theme. It was estimated a reworking of the site would cost between \$7,000 and \$11,000.

There was discussion regarding the level of autonomy the City would have in editing the new site. It was indicated the City could choose its level of autonomy based on cost, training and time factors. Municipal Web will provide maintenance services for an hourly fee of \$45.

There was discussion regarding creating a social media site for the City, setting up RSS feeds, creating a static website and reserving frequently changing materials for a social media site, and whether the City has personnel to dedicate to the task. Council was particularly interested in obtaining information on the number of hits on the site, hits on certain pages and recent searches on the site. They hope to use the details to determine what information should be accessible on the site and what information is extraneous.

On August 15, 2011, the city clerk received an application for tax abatement along with an application for a Personal Property IFT. Initial Review indicated the applicant met the requirements for tax abatement.

To review, in December 2010, city staff met with representatives from Machine Tool and Gear, SEDP and City of Corunna, to discuss the expansion of their operations from City of Corunna to Owosso. The meeting revealed the need for this expansion due to growth in their business and also required the acquisition of a facility in the City of Owosso. Earlier this year, council granted a Personal Property IFT for \$540,000. New business has required additional growth in employment, (9 new employees), and acquisition of an additional \$1,326,975 in personal property. With this new expansion, there are now 73 employees in the Owosso plant with a pay scale exceeding \$12.00 per hour

An Industrial Facilities Tax Exemption Certificate, Act 198 of 1974, is a tax abatement which reduces the tax burden by 50%. The applicant is applying for the IFT exemption on personal property only. This exemption can be granted for up to 12 years.

An Industrial Development District for that area was established April 18, 1977 and amended October 9, 1978 to include all the property at that site and match the description on the assessment roll.

The next step in the process is to set the public hearing for an Industrial Facilities Tax Exemption Certificate. Attached is the resolution setting September 19, 2011 as the date for this hearing. The city clerk has notified the taxing jurisdictions of this application as required under the city's abatement policy and will forward any responses to you. 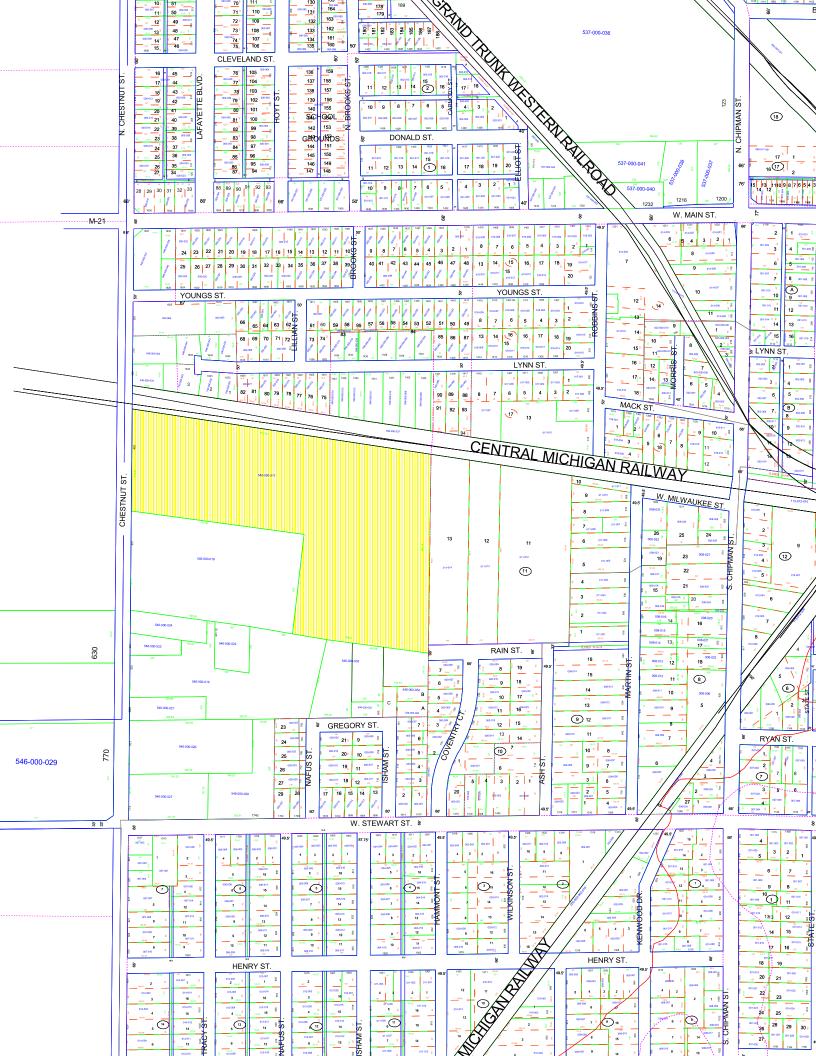

On August 15, 2011, the city clerk received an application for tax abatement from Machine Tool and Gear and on August 26, 2011 received an application to transfer four (4) Personal Property Industrial Facilities Tax Exemption Certificates from their plant in the City of Corunna. As part of an ongoing process, beginning with a kickoff meeting last December, these transfers will culminate one of the most positive impacts of job growth in both communities and the county in many years. As a part of the redrawing of the floodplain maps FEMA requires each affected municipality to adopt rules governing construction within flood prone areas.

In the interest of keeping things simple staff is recommending the current ordinance be repealed in its entirety and replaced by the attached language.

# AN ORDINANCE ADOPTING A NEW CHAPTER 14, FLOOD PROTECTION, AND AGREEING TO COMPLY WITH THE REQUIREMENTS OF THE NATIONAL FLOOD INSURANCE ACT OF 1968, AS AMENDED AND REPEALING IN ITS ENTIRETY THE CURRENT CHAPTER 14, FLOOD PROTECTION

WHEREAS, the City of Owosso currently participates in the Federal Emergency Management Agency's (FEMAs) National Flood Insurance Program (NFIP) by complying with the program's applicable statutory and regulatory requirements for the purposes of significantly reducing flood hazards to persons, reducing property damage, and reducing public expenditures, and providing for the availability of flood insurance and federal funds or loans within its community, and

WHEREAS, the NFIP requires that floodplain management regulations must be present and enforced in participating communities, and utilize the following definitions, which also apply for the purposes of this ordinance, and

WHEREAS, the *Stille-Derossett-Hale Single State Construction Code Act, Act No. 230 of the Public Acts of 1972, as amended*, along with its authorization of the state construction code composed of the *Michigan Residential Code* and the *Michigan Building Code* and its appendices, specifically Appendix G, contains floodplain development and management regulations that comply with the FEMA NFIP minimum floodplain management criteria for flood prone areas, as detailed in Title 44 of the Code of Federal Regulations (44 CFR), Section 60.3; and

WHEREAS, the city of Owosso has accepted the responsibility to administer, apply, and enforce the provisions of the construction code act and the state construction code, specifically the *Michigan Residential Code* and the *Michigan Building Code*, to all construction within its community boundaries appearing as Chapter 8, Buildings and Building Regulations of the *Code of Ordinances of the City of Owosso, Michigan*;

NOW, THEREFORE, BE IT RESOLVED by the City Council for the City of Owosso, Michigan to maintain eligibility and continued participation in the NFIP adopts the following to be designated Chapter 14, Flood Protection:

THE CITY OF OWOSSO ORDAINS: that Chapter 14, <u>Flood Protection</u>, be amended as follows:

Section1: Secs. 14-1 through 14-4 will read as follows:

#### Sec. 14-1. Definitions.

Flood or Flooding means:

- a. A general and temporary condition of partial or complete inundation of normally dry land areas from: 1) the overflow of inland or tidal waters, 2) the unusual and rapid accumulation or runoff of surface waters from any source, 3) mudflows, and
- b. The collapse or subsidence of land along the shore of a lake or other body of water as a result of erosion or undermining caused by waves or currents of water exceeding anticipated cyclical levels or suddenly caused by an unusually high water level in a natural body of water, accompanied by a severe storm, or by an unanticipated force of nature, such as flash flood or an abnormal tidal surge, or by some similarly unusual and

unforeseeable event which results in flooding, as defined in paragraph a.1) of this definition.

Flood insurance rate map (FIRM) means the official map, which the Federal Emergency Management Agency (FEMA) has delineated both the risk premium zones applicable to the community and the Special Flood Hazards Areas designated as Zone A, AE, AH, AO, AR, A99, V or VE.

Floodplain means any land area susceptible to being inundated by water from any source.

Floodplain management means the operation of an overall program of corrective and preventive measures for reducing flood damage, including but not limited to emergency preparedness plans, flood control works, and floodplain management regulations.

Floodplain management regulations mean zoning ordinances, subdivision regulations, building codes, health regulations, special purpose ordinances, such as a floodplain ordinance, and other applications of police power that provide standards for the purpose of flood damage prevention and reduction.

Structure means a walled and roofed building that are principally above ground, gas or liquid storage facility, as well as a mobile home or manufactured unit.

#### Sec. 14-2. Enforcement.

The City of Owosso directs its designated enforcing agent for the construction code act, the Code Enforcement Official, to administer, apply, and enforce the floodplain management regulations as contained in the *Michigan Building Code*, including Appendix G, and to be consistent with those regulations by:

- a. Obtaining, reviewing, and reasonably utilizing flood elevation data available from federal, state, or other sources pending receipt of data from the FEMA to identify the flood hazard area and areas with potential flooding.
- b. Ensuring that all permits necessary for development in floodplain areas have been issued, including a floodplain permit, approval, or letter of no authority from the Michigan Department of Natural Resources and Environment under the floodplain regulatory provisions of Part 31, "Water Resources Protection," of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.
- c. Reviewing all permit applications to determine whether the proposed building sites will be reasonably safe from flooding. Where it is determined that a proposed building will be located in a flood hazard area or special flood hazard area, the construction code act enforcing agent shall implement the following applicable codes according to their terms:
  - (1) Floodplain management regulation portions and referenced codes and standards of the current *Michigan Residential Code*.
  - (2) Floodplain management regulation portions and referenced codes and standards of the current *Michigan Building Code*.
  - (3) Appendix G of the current *Michigan Building Code*.

- d. Reviewing all proposed subdivisions to determine whether such proposals are reasonably safe from flooding and to ensure compliance with all applicable floodplain management regulations.
- e. Assisting in the delineation of flood hazard areas, providing information concerning uses and occupancy of the floodplain or flood-related erosion areas, maintaining floodproofing and lowest floor construction records, and cooperating with other officials, agencies, and persons for floodplain management.
- f. Advising FEMA of any changes in community boundaries, including appropriate maps.
- g. Maintaining records of new structures and substantially improved structures concerning any certificates of floodproofing, lowest floor elevation, basements, floodproofing, and elevations, to which structures have been flood proofed.

#### Sec. 14-3. Flood Insurance Rate Maps.

The city of Owosso assures the Federal Insurance Administrator that it intends to review, on an ongoing basis, all amended and revised Flood Insurance Rate Maps (FIRMs) and related supporting data and revisions thereof and revisions of 44 CFR, Part 60, Criteria for Land Management and Use, and to make such revisions in its floodplain management regulations as may be necessary to continue to participate in the program.

#### Sec. 14-4. Flood Insurance Studies.

The Federal Emergency Management Agency (FEMA) Flood Insurance Study (FIS) entitled "Flood Insurance Study - City of Owosso, Michigan, Shiawassee County," dated January 16, 2003 with accompanying "Flood Insurance Rate Map" dated January 16, 2003 and "Hydrologic & Hydraulic Analysis of Owosso Drain" dated March, 2011, are hereby adopted by reference and declared to be a part of this Ordinance for the purposes of administration of the *Michigan Construction Code*, and declared to be a part of Section 1612.3 of the *Michigan Building Code*, and to provide the content of the "Flood Hazards" section of Table R301.2(1) of *the Michigan Residential Code*, and also adopts the Base Flood Elevation that the Federal Emergency Management Agency has declared for the Shiawassee River, which is indicated on said Flood Insurance Rate Maps.

#### Section 2. Repeal Clause.

Chapter 14, Flood Protection, of the *Code of Ordinances of the City of Owosso* is hereby repealed and replaced by this ordinance and all other ordinances in conflict with this ordinance are hereby repealed to the extent of the conflict.

#### Section 3. Severability.

If any section, subsection, sentence, clause, phrase or portion of this amendment for any reason is held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions hereof.

#### Section 4. Effective Date.

This ordinance shall take effect twenty days after its passage.

This Ordinance may be purchased or inspected in the City Clerk's Office Monday through Friday between the hours of 9:00 a.m. and 5:00 p.m.

RE: Change Order 2 for 2010 Curb and Gutter Program

We allowed Sumbera Excavating to begin the 2010 Curb and Gutter Program 6 weeks early because it was funded by the bond issue so it was not necessary to begin after July 1<sup>st</sup> as originally planned.

The Water Department began replacing the water main under Jerome Street between Gould and Oakwood on May 18<sup>th</sup> and finished on July 9<sup>th</sup>. When Sumbera was ready to put new curbs on Jerome Street the new water main was not completed yet and Sumbera was delayed two weeks in finishing the curb work on Jerome Street. This delay resulted in two extra weeks of barricading costs that Sumbera had not planned on when bidding the job. They are requesting the City reimburse them \$873.00 for the extra barricading costs due to the delay.

We are recommending the Council approve Change Order 2 in the amount of \$873.00 and approve payment up to that amount.

- 2. <u>Policy</u>. To vote on Core Legislative Principles document and resolutions properly brought before the annual meeting. All member municipalities planning on submitting resolutions for consideration at the annual meeting are reminded that under the Bylaws, <u>the deadline for League Trustees to receive resolutions for their review is September 2, 2011</u> (please see page 2).
- 3. Other Business. To transact such other business as may properly come before the meeting.

#### Designation of Voting Delegates

Pursuant to the provisions of the League Bylaws, you are requested to designate by action of your governing body one of your officials who will be in attendance at the Convention as your official representative to cast the vote of the municipality at the annual meeting, and, if possible, to designate one other official to serve as alternate. Please submit this information through the League website by visiting http://www.mml.org/delegate no later than September 21, 2011.

Regarding the designation of an official representative of the member to the annual meeting, please note the following section of the League Bylaws:

"Section 4.4 - <u>Votes of Members</u>. Each member shall be equally privileged with all other members in its voice and vote in the election of officers and upon any proposition presented for discussion or decision at any meeting of the members. Honorary members shall be entitled to participate in the discussion of any question, but such members shall not be entitled to vote. The vote of each member shall be cast by its official representative attending the meeting at which an election of officers or a decision on any proposition shall take place. Each member shall, by action of its governing body prior to the annual meeting or any special meeting, appoint one official of such member as its principal official representative to cast the vote of the member at such meeting, and may appoint one official as its alternate official representative to serve in the absence or inability to act of the principal representative."

#### 1. Election of Trustees

Regarding election of officers, under Section 5.3 of the League Bylaws, six members of the Board of Trustees will be elected at the annual meeting for a term of three years. The regulations of the Board of Trustees require the Nominations Committee to complete its recommendations and post the names of the nominees for the Board of Trustees on a board at the registration desk at least four hours before the hour of the business meeting.

#### 2. Statements of Policy and Resolutions \*

Regarding consideration of resolutions and statements of policy, <u>under Section 4.5 of the League Bylaws</u>, the Board of Trustees acts as the Resolutions Committee, and <u>"no resolution or motion, except procedural and incidental matters having to do with business properly before the <u>annual meeting or pertaining to the conduct of the meeting, shall be considered at the annual meeting unless it is either (1) submitted to the meeting by the Board of Trustees, or (2) submitted in writing to the Board of Trustees by resolution of the governing body of a member at least thirty (30) days preceding the date of the annual meeting." Thus the deadline this year for the League to receive resolutions is September 2, 2011.</u></u>

"Every proposed resolution submitted by a member shall be stated in clear and concise language and shall be accompanied by a statement setting forth the reasons for recommending the proposed resolution. The Board shall consider the proposal at a Board meeting prior to the next annual meeting and, after consideration, shall make a recommendation as to the advisability of adopting each such resolution or modification thereof."

The proposed Michigan Municipal League Core Legislative Principles and any new proposed Resolutions recommended by the Board of Trustees for adoption by the membership are available on the League website\*, to permit governing bodies of member communities to have an opportunity to review such proposals and delegate to their voting representative the responsibility for expressing the official point of view of the member at the annual meeting.

RE: OPRA Resolution Amendment

On August 15, 2011 Council approved Resolution No. 130-2011 approving a 6 year Obsolete Property Rehabilitation Exemption Certificate for Wesener, LLC for the property located at 104-108 North Washington Street. The completed exemption application and resolution were subsequently sent to the State Tax Commission for final approval. A review of the resolution by the State found some clarification is necessary. Because the exemption was granted for a period less than the maximum 12 years they are requesting Council amend the resolution to include a statement indicating either there is no opportunity for an extension of the original application, or if opportunity will be afforded what criteria would be used in determining an extension. As the applicant requested only a 6 year abatement and any additional years would offer them no advantage due to the brownfield plan in place it is our recommendation Council amend the resolution to indicate there is no opportunity for an extension of the abatement. Attached you will find an amended version of Resolution No. 130-2011 with the added text in bold type.

Staff recommends approval of Resolution No. 1302-11, as amended.

#### RESOLUTION NO. 130-2011, AS AMENDED SEPTEMBER 6. 2011

# A RESOLUTION TO APPROVE THE APPLICATION FOR AN OBSOLETE PROPERTY REHABILITATION EXEMPTION CERTIFICATE FROM DAVE ACTON OF WESENER, LLC FOR PROPERTY LOCATED AT 104–108 N. WASHINGTON STREET

WHEREAS, the City of Owosso is a Qualified Local Government Unit within the State of Michigan and is empowered to provide tax exemptions for increased value of rehabilitated facilities within the City; and

WHEREAS, after public notice and a public hearing on March 1, 2004, the City Council of the City of Owosso approved an Obsolete Property Rehabilitation District at 104-108 N. Washington Street in Owosso, Michigan at said meeting, as provided by section 4(2) of Public Act 146 of 2000. Said property more particularly described as:

S 2/3 OF LOT 5 & N 1/3 OF LOT 6 (EX E 22' OF LOT 6) BLK 21 ORIGINAL PLAT

WHEREAS, the City Clerk received a complete application and required documentation on July 27, 2011 from Dave Acton, authorized agent for Wesener, LLC, owner of the property, for an Obsolete Property Rehabilitation Exemption Certificate requesting a 6 year abatement; and

WHEREAS, notice of a public hearing concerning the application for an exemption certificate was provided to the Assessor of the City and the legislative body of each taxing unit that levies ad valorem property taxes in the City; and

WHEREAS, the City finds that the property meets the definition of an obsolete property as defined in section 2(h) of Public Act 146 of 2000 and the application for the exemption certificate is complete; and

WHEREAS, the City finds that the property relates to a rehabilitation program that when completed constitutes a "rehabilitated facility" within the meaning of P.A. 146 of 2000, and said property is located within an Obsolete Property Rehabilitation District established in a Qualified Local Governmental Unit eligible under Public Act 146 of 2000 to establish such a district; and

WHEREAS, the rehabilitation includes improvements aggregating 10% or more of the true cash value of the property at commencement of the rehabilitation as provided by section 2(I) of PA 146 of 2000; and

WHEREAS, it has been found that the rehabilitation of the obsolete property is calculated to, and will at the time of the issuance of the certificate, have the reasonable likelihood to increase commercial activity, retain and create employment, and revitalize the downtown; and

WHEREAS, the taxable value of the property proposed to be exempt plus the aggregate taxable value of the property already exempt under PA 146 of 2000 and under PA 198 of 1974 does not exceed 5% of the total taxable value of the unit; and

WHEREAS, the applicant is not delinquent in any taxes related to the facility; and

WHEREAS, the rehabilitation work described in the application had not commenced prior to the establishment of the District.

NOW, THEREFORE, BE IT RESOLVED that, based on the findings above made at public hearing, the City Council of the City of Owosso authorizes the application for an Obsolete Property Rehabilitation Exemption Certificate at 104-108 N. Washington Street for a period of 6 years as requested by the applicant, **and no further extensions of this certificate will be allowed**; and

ALSO, BE IT RESOLVED that the rehabilitation shall be completed within eighteen (18) months from the date of approval of said application, and

FURTHERMORE, BE IT RESOLVED that the application and resolution are authorized for submittal to the State Tax Commission for final review and authorization.

- ✓ Kayak launch sites in and out of town
- ✓ A walleye fishery
- ✓ The city property at the water treatment plan could open more area to public access.
- ✓ Low head dams could be upgraded such as the one by the M-21 bridge in town, and make it more natural looking.
- Upgrade the riverwalk to Corunna and provide better access areas.
- Improve river esthetics by ridding it of invasive plant species and planting more natural species.
- Relocate the bus garage and open the area for a park use.
- Maybe look to Cass Street for a trailhead.

His group hopes to be a partner with the Parks and Recreation Commission.

Frederick Dibean suggested paving the parking lot at the Bennett Field. It has heavy erosion and several deep drops.

City Councilmember Joni Forster spoke about the Parks and Recreation Commission needing a comprehensive plan and that each park needs an individual evaluation. She recommends more community involvement and better notification of public meetings. She advised to take the time and do it well.

The meeting was opened to the board members.

Commissioner Hebekeuser was pleased to see the attendees and hear the great suggestions. We need to make it work.

Commissioner Chavora commented that the board talked about going through the plan several pages at a time. We have several great suggestions and need to keep it going.

Mr. Zettel stated he would add Chapter 13 – Trails, and Chapter 14 – Non Park Lands. Those would be recreational such as the area near the water treatment plant. This would be added to the Master Plan also.

Chairperson Ladd stated that a new splash pad may not be in a park or even in the city. Ms. Ladd went to a regional meeting to discuss assets and needs in the community. The Shiawassee River was a very high priority along with Baker College.

Mr. Hebekeuser agrees with Mr. Dibean's comments regarding Bennett Field.

Mr. Zettel stated that we need to build more flexibility in the Parks and Recreation Plan so if someone comes up with a special fund something may move ahead. When special groups bring in plans and resources, that project may move ahead.



The board decided to hold a special meeting on Tuesday, September 13 at 6 p.m. to work on the Parks and Recreation Plan.

#### 2. Disc Golf

Jonathon Beebe. 1309 N. Hickory Street, discussed the benefits of disc golf – mostly it being great exercise and a lot of fun. McCurdy Park installed theirs in 2009 and he was part of that process.

Darcey Crank, 317 S. Elm, talked about the principles of the game and showed the board a disc. It costs about \$5-6,000 for the course. He had checked out some of the parks and favored Rosevear Park. It could be installed without cutting any trees. It has water and there would be no clearing of brush. This game is becoming more and more popular and several surrounding communities have them too. He continued that fundraising could involve the Cook Foundation, or local businesses could sponsor a hole with advertising – possibly restaurants for after game refreshments.

Commissioner Selbig commented Rosevear Park should be a priority. There is so much that needs to be done there – it's very overgrown.

Mr. Hebekeuser asked the men to keep coming to the Parks and Rec meetings, and to please come back on September 13.

Mr. Crank answered a question and said that the Par was three on each hole.

#### 3. Fundraising Update/Bentley Park

Commissioner Chavora stated that the last event raised \$700. The next event will be a Concert in the Park at Bentley Park on the first Friday after Labor Day.

#### **Staff Comments:**

Mr. Zettel stated the Kiwanis wanted to combine the first two phases / renderings. The board was in general consensus that the renderings were firm in their design for the playscape at Bentley Park.

#### Adjournment:

A motion to adjourn the meeting was made by Commissioner Hebekeuser and was supported by Commissioner Brown. The meeting adjourned at 7:00 p.m. Ayes: all, motion carried

ITEMS OF DISCUSSION: MASTER PLAN PUBLIC OUTREACH

Adam Zettel, Assistant City Manager and Director of Community Development, reviewed some points from his memo to the commissioners dated August 15, 2011. Discussion began regarding the disbursement of the survey. Suggestions were online at the city's website, at the Farmers and Artisan Markets, presentation to various groups, though the water bill, possible direct mail, and notices in the newspaper. Various names were taken by Mr. Zettel for contact and inclusion to these groups. He will speak to the individuals and set up the times for the focus groups to meet.

Mr. Zettel noted that he talked to Gary Palmer about the newest Premier Waste building at 1901 W. South Street. The building will be 40 x 60 feet at this time with the possibility to expand to the full 100 feet when the economy improves. A letter was delivered explaining the change to the site plan. Discussion continued with Commissioner Fox about the berm still not being done. Mr. Zettel said the berm was done and it would too difficult to change it now. Chairman Wascher commented about the dead trees. Mr. Zettel stated those could be replaced.
