# **CITIZEN COMMENTS AND QUESTIONS**

Tim Law, owner of the Rainbow Bar invited everyone to the Westown Chili cook-off on Saturday from 3:00 p.m. to 6:00 p.m.

Michael Bruff, local realtor, 707 West King Street, commented on the proposed pricing structure for the Osburn Lakes subdivision. He asked that Council consider further reducing lot prices and make changes to the development agreement to waive the building requirement.

June Coon, rental property owner, 615 Ridgeview Drive, Corunna, listed her objections to the rental inspection program, including the cost and the intrusion into her life and that of her renters. She went on to say that she felt the City was targeting rental owners and she felt firefighters should not be performing the inspections.

Mayor Frederick responded to Mrs. Coon's comments saying he fully supported the rental inspection program, felt the \$25 registration fee was fair, and it was a good use of City resources in return for better housing conditions for local residents.

There was discussion regarding the timing of inspections. It was noted inspections take place at the convenience of the tenant and landlord.

Councilperson Erfourth noted that his family owns rental property in Lansing and East Lansing and inspection fees range anywhere from \$300 to \$595 per unit. He also noted the City's inspection program is targeted at basic hazards and is not overly burdensome.

Councilperson Cook indicated he appreciated Mrs. Coon's feedback on the inspection program and asked for her suggestions as to how landlords and the City could work together to improve the quality of housing in the City.

# CITY MANAGER REPORT

City Manager Crawford detailed the monthly status report.

There was a brief discussion regarding potential changes to the water and sewer agreements with the City of Corunna. Mr. Crawford indicated Corunna had received a grant from the federal government but their receipt of those funds hinged on whether the City would be willing to make changes to the water and sewer agreements with them. The topic will be fully addressed at the March 7<sup>th</sup> meeting.

There was further discussion regarding the clean-up after the recent snow storm.

Lastly there was a discussion about the Governor's proposed budget and how it may affect the City. It was noted there were a number of proposals that could potentially affect the City but how and to what extent is not known at this time. A clearer picture will emerge as the Legislature begins negotiations on the budget and details of the various proposals come out.

WHEREAS, the city of Owosso, Shiawassee County, Michigan, has a fire department requiring the use of emergency medical equipment, firefighting equipment and personnel;

WHEREAS, the city of Owosso received an assistance to firefighters grant (AFG) award in the amount of \$63,624.00 for emergency medical equipment; \$33,600.00 for firefighting equipment; \$3,000.00 for training; and \$3,000.00 for training instructors; and

WHEREAS, the city of Owosso local match is 5% or \$5,161.00;

## FARMERS MARKET ESTABLISHMENT

There was a lengthy discussion regarding how the two organizations that originally proposed to hold a market felt about the plan, whether the DDA was a good fit for the administration of the market, and ensuring the market will be able to begin as planned in light of the preparations that need to be made. It was noted the proposal would be to hold the market one last year in the Armory Parking lot and use the existing rules and regulations, with minor changes, in order to accommodate the opening of the market as well as the concerns of the vendors involved in the original market. City Attorney Brown strongly suggested any organization that is formed as result of this discussion seek formal organization prior to the start of the market.

A motion was made by Councilperson Eveleth and seconded by Councilperson Cook to authorize the resolution establishing the market as presented, with the addition of the closure of the Armory Parking Lot.

Friendly amendments were made to include a contingency for the submission of rules and regulations as well as a request for a status report by the March 21<sup>st</sup> meeting to ensure the effort remains cohesive and headed in the proper direction.

The final motion, originally made by Councilperson Eveleth, reads as follows: Motion to authorize the following resolution establishing a farmers market administrated by Owosso Main Street/Downtown Development Authority, authorizing Traffic Control Order No. 1248 for the closure of the Armory Parking Lot and Exchange Street from Water Street to Park Street from 6:00 a.m. to 5:00 p.m. on Saturdays from May through October 2011 contingent upon the submission of rules and regulations, and directing staff to submit a status report on the progress of the proposal no later than March 21<sup>st</sup>.

# **RESOLUTION NO. 38-2011**

#### APPROVING TRAFFIC CONTROL ORDER GRANTING PERMISSION TO THE OWOSSO DOWNTOWN DEVELOPMENT AUTHORITY FOR USE OF EXCHANGE STREET BETWEEN PARK AND WATER STREETS FOR EVENTS ON SATURDAYS

WHEREAS, the city of Owosso has jurisdiction over streets, alleys, sidewalks and parklands within the city of Owosso and has the responsibility to provide police, emergency medical and other services for the welfare of the residents;
