ARBOR DAY PROCLAMATION

Mayor Frederick read aloud the following proclamation of the Mayor's Office declaring May 5, 2012 as Arbor Day in the City of Owosso:

A PROCLAMATION OF THE MAYOR'S OFFICE OF THE CITY OF OWOSSO, MICHIGAN DESIGNATING MAY 5, 2012 AS ARBOR DAY IN THE CITY OF OWOSSO

- *Whereas,* In 1872, J. Sterling Morton proposed to the Nebraska Board of Agriculture that a special day be set aside for the planting of trees, and
- *Whereas,* this holiday, called Arbor Day, was first observed with the planting of more than a million trees in Nebraska, and
- *Whereas,* Arbor Day is now observed throughout the nation and the world, and
- *Whereas,* trees can reduce the erosion of our precious topsoil by wind and water, cut heating and cooling costs, moderate the temperature, clean the air, produce life-giving oxygen, and provide habitat for wildlife, and
- *Whereas,* trees are a renewable resource giving us paper, wood for our homes, fuel for our fires and countless other wood products, and
- *Whereas,* trees in our city increase property values, enhance the economic vitality of business areas, and beautify our community, and

Whereas, trees, wherever they are planted, are a source of joy and spiritual renewal.

PUBLIC HEARINGS

REZONING REQUEST – 1484 WEST KING STREET

A public hearing was conducted to receive citizen comment regarding request to rezone the parcel commonly known as 1484 West King Street from I-1, Light Industrial to R-1, Single Family Residential.

There were no citizen comments.

Mayor Pro-Tem Popovitch noted the Planning Commission vetted the request and approved it unanimously.

Whereas, the Council, after due and legal notice, has met and there being no one to be heard, motion by Mayor Pro-Tem Popovitch that the following ordinance be adopted:

ORDINANCE NO. 731

AMENDING CHAPTER 38 ZONING OF THE CODE OF ORDINANCES TO REZONE A SPECIFIC PARCEL OF REAL PROPERTY AND AMEND THE ZONING MAP

Whereas, the city council of the city of Owosso received a petition from a land owner of real property identified as 1484 West King Street, parcel 050-450-000-039-00, lots 36, 39, & 40 of the Oak Grove Addition to rezone the parcel from I-1 Light Industrial to R-1 One Family Residential.

Whereas, the city council referred the request to the planning commission, and the planning commission subsequently published the request, held a public hearing on the request, and deliberated on the request;

Whereas, the city staff and planning commission recommend, without reservations or conditions, the rezoning of 1484 West King Street as petitioned;

Therefore, Be It Resolved, that Chapter 38, Zoning Code of the City of Owosso be amended as follows

THE CITY OF OWOSSO ORDAINS:

Section 1. That Chapter 38, Zoning Code of the City of Owosso Sec. 38-27 Zoning Districts and Map reflect the following change to be noted on the official map and filed with the city clerk:

Indicate a zoning classification of R-1 One Family Residential for 1484 West King, parcel 050-450-000-039-00.

Section 2. This amendment shall become effective May 6, 2012.

Section 3. This ordinance may be purchased or inspected in the city clerks' office, Monday through Friday between the hours of 9:00 a.m. and 5:00 p.m.

CITIZEN COMMENTS AND QUESTIONS

County Commissioner Ronald Elder provided the Council with an update on the latest at the County level including their approval of the installation of 3 canoe launches along the river and authorization to seek a full time director for the Veteran's Affairs Office.

Eddie Urban, 601 Glenwood Avenue, said the lot on Corunna Avenue east of Gould Street looks nice now that the building has been torn down.

Councilperson Fox presented 185 letters he had collected objecting to the conversion of north M52 from 4 lanes to 3. He asked that copies be taken for the record. He will submit them to MDOT later in the week. He also asked that his concerns regarding the recent lay off of two members of the Public Safety Department be placed on the May 7th agenda for discussion.

CITY MANAGER REPORT

City Manager Crawford updated the Council on the preparations for the reconstruction of west M21 and north M52 saying MDOT has announced a meeting on April 19th to gather citizen

comments on the projects. He went on to say that there is some confusion as to whether comprehensive traffic studies have been performed and will be available to Council so an educated recommendation can be made. Council agreed if the information was not available at the meeting on the 19th a formal request would be made to obtain it.

City Manager Crawford also noted that some of the new LED lights had been installed in front of City Hall.

Councilperson Fox inquired about the new employee sharing agreement with Corunna. City Manager Crawford noted the employee in question would work part time for both organizations to assist Public Safety officials with official correspondence and reporting to state agencies.

WHEREAS, efficiencies can be gained from contracting out for service to mow such properties; and

WHEREAS, the City of Owosso sought bids for the mowing of weed ordinance violation properties and a bid was received from Sunburst Gardens, Inc.; and it is hereby determined that Sunburst Gardens, Inc. is qualified to provide such services and that it has submitted the lowest responsible and responsive bid;

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Owosso, Shiawassee County, Michigan that:

- FIRST: The City of Owosso has heretofore determined that it is advisable, necessary and in the public interest to employ Sunburst Gardens, Inc. for the service of mowing properties in violation of the weed ordinance upon the city's request.
