#### **CITIZEN COMMENTS AND QUESTIONS**

Tom Manke, Owosso Township resident, said he had read that Owosso was in the top 16 cities in Michigan with lead contamination in the water. He said he wanted all the sampling data posted and would like to know what the City is going to do to fix the problem.

Mike Espich, 1124 Ada Street, said he sees the water issue a little differently, while he trusts the City he said it is still important for people to have the water in their homes tested. He plans on doing so and will report back on results.

Lt. Pamela Battinkoff, Central Dispatch 911 Director, detailed the 911 sur charge request on the March 8<sup>th</sup> ballot. She noted the decline in revenues, equipment upgrades required by the State, and the fact that this sur charge is the only source of funding for 911 operations as reasons to approve the measure.

Utilities Director Glenn M. Chinavare addressed Mr. Manke's concerns, saving the reason for testing was to locate high lead levels to prevent harm to those residents using water at that location. He said that any reports showing high lead levels are followed up with residents, efforts are made to educate them and determine the best course of action. He went on to say that plumbing fixtures and lead service lines are the major sources of lead contamination in tap water. The City is required to replace any lead lines it finds in the City portion of the system, and he also encourages residents to replace lead service lines on private property when a street is reconstructed by offering to let residents piggy-back on the City contract for the work. In further testament to the water quality he said he contacted the Shiawassee County Health Department and Memorial Hospital to inquire whether they had reports of high lead levels and they did not. He also had not received any reports from any industrial customers regarding the state of the water.

Two Council members then spoke about their personal experiences with lead exposure (via tap water and paint), how the situations were resolved, tips for reducing exposure, local resources for help with lead in homes, and the need for an educational effort. Mr. Chinavare indicated that public education and media outreach are very important and are things he intends to implement in the future.

There were further questions for Mr. Chinavare regarding a spike in lead levels at the same sampling location and the protocol when high lead levels are found. Director Chinavare indicated that the sample showing the spike in lead levels was due to the fact that the resident of the home was out of town immediately prior to the test and water sat in the pipes for several days before being tested. He also indicated that every test site is issued a report and based on the findings of that report a follow-up appointment may be required to educate the resident on the risks at hand and discuss potential solutions and/or mitigation, but many times control of the situation is up to the resident.

Mayor Frederick asked Director Chinavare what he felt the main factors were leading to Flint's water problem. Mr. Chinavare noted two things he felt had a major impact on the situation: the switch in water sources and regulatory issues that allowed processes to get in the way of good judgement. Lastly he noted that he is happy to talk with residents that have concerns about their water and that water testing is free to residents.

City Manager Crawford provided an update on the status of the Cargill development indicating there are several things the Council will need to agree to in the coming months if the project is to move forward.

#### **Disc Golf Course Update** (This item was added to the agenda.)

Parks & Recreation Commission Chairman Mike Espich was on hand to inform Council about the controversy over the proposal to install a disc golf course in Collamer Park. He detailed the Commission's previous efforts to place the course in Rosevear Park and how those efforts were thwarted leading to the current proposal to place it in Collamer Park. He noted that current users of the park (bikers, hikers, bird watchers, etc.) had concerns about incorporating the golf course into the park for numerous reasons. He went on to say that the Commission is currently waiting for a revised layout that will then be staked and vetted by users, with final recommendation to be determined by the Commission and referred to Council and that no one had been given permission to start constructing the course at this point.

#### **CITIZEN COMMENTS AND QUESTIONS**

Tom Manke, Owosso Township resident, thanked Council for the water discussion, but asked again for the sample data. He also suggested the new police cars not be labeled as "public safety" vehicles.

Mayor Frederick noted the water quality report is posted on the City website for anyone that would like to view it.

Eddie Urban, 601 Glenwood Avenue, questioned whether Flint residents really didn't know they should get their water tested.

Mike Espich, 1124 Ada Street, thanked the Utilities Director for his comments and the opportunity for a free water test.

Mayor Frederick clarified the statistics regarding the City's lead levels saying the DEQ report indicates the reported amount was 11ppb, not the 13ppb noted by the Argus Press.
