CITIZEN COMMENTS AND QUESTIONS

Kathryn Burkholder from Consumers Energy, 1000 Grand Oaks Dr., Howell discussed the new, upgraded meters that will be coming in spring or early summer. They will have a cell phone chip in them and every night Consumers will get a text type message with notifications, including accurate reads so customers receive an accurate bill. Customers will be able to go online and look at their hourly energy usage. The outage management system will tell when customers are out of power. Communications from Consumers will be coming a month ahead of getting the new meters and then two weeks before installation. Customers do not need to be home for the installation and will be notified by a door hangar when the work is complete. Customers can opt-out from the new meters, but will see a one-time opt-out fee of \$69.39 and then \$9.72 per meter read.

Phil Hathaway, 736 Elmwood St., has known Ben Frederick since he was a child. He thanked Ben for growing up and serving the city for so many years.

Eddie Urban, 601 Glenwood, Friday is Veteran's day and Central School is having a program for veterans.

Mike Espich, 1124 Ada St., and Chair of the Parks and Recreation Commission. Started in September, 2012 to improve the skate park. Spent a year and raised money and came up with a great idea for a new park. Moving the Grove Holman location with the new park will cost around \$250,000. We won't need to build restrooms or a parking lot, since it's already there. Grove Holman is an under-utilized park since it's primarily used for winter sledding. This will bring summer activity to the park. With passage of this relocation of the skate park, we can move forward.

CITY MANAGER REPORT

Sitting in for City Manager Donald D. Crawford, Assistant City Manager Susan K. Montenegro presented a project status report. On the Cargill/Sonoco roadway project, Crawford Contracting started brush clearing today at the site for the roadway and utility project. A pre-construction meeting was held for the Lincoln School project, permits have been pulled and work is underway. Staff is reviewing presentations and proposals on the AMR meter reading system. The North Street culvert is fully complete and grass is growing. Construction has been put on hold at the Shiawassee Sanitary Landfill site. Equipment condition assessment was completed last week for the SAW grant for WWTP, the structural evaluation will happen next in November. Sewer modeling has been done for the SAW grant collection system. Final plans are ready for submission to MDOT for the East Oliver Street project. Brush cleaning has been completed for the utility easement for the Heintz Road well replacement. Street patches and sidewalks are complete. City leaf crews have begun the second pass through the city today and will likely require a third pass because of the late fall. The audit team arrived today.

Mayor Frederick stated that we will definitely need to do a third sweep for leaves.

Councilperson Fox clarified when the East Oliver Street meeting with residents will take place and that is on Thursday, November 10 from 4:00pm to 6:00pm in the Council Chambers of City Hall.

AUTHORIZING SERVICE AGREEMENT AND PAYMENT TO LAKESIDE EQUIPMENT CORPORATION FOR PURCHASE OF HVAC SYSTEM AT THE WASTEWATER TREATMENT PLANT

WHEREAS, the City of Owosso, Shiawassee County, Michigan, has budgeted from the Wastewater Plant Replacement Fund for the replacement of a HVAC System; and

WHEREAS, the existing HVAC System boilers are beyond economical overhaul and have expended their operational service life, and competitive bids were solicited and received to replace the aged inefficient boilers with more efficient HVAC units, and William Floyd Mechanical Contractors provided the low and responsive price in the amount of \$101,027.00; and

WHEREAS, the City Utilities Director has reviewed the proposal and verified the replacement units needed to replace the HVAC heating system, and recommends authorizing William Floyd Mechanical Contractors to provide the equipment and installation services in the amount of \$101,027.00, plus contingency funds in the amount of \$6,000.00, for a total of \$107,027.00.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Owosso, Shiawassee County, Michigan that:

WHEREAS, the City of Owosso, Shiawassee County, Michigan, Parks & Recreation Commission met September 27, 2016 and recommends approval of Grove Holman Park as the location for the new skate park yet to be built; and

WHEREAS, the new skate park would aid the Parks & Recreation Commission in achieving its number one priority to promote healthy lifestyles, attract tourists and offer recreational outlets; and

WHEREAS, the Parks and Recreation Commission, along with staff, will be seeking funding for the new skate park through donations and future grants.

FIFTH AMENDMENT TO SALE AND PURCHASE OF PROPERTY AGREEMENT WITH CARGILL, INCORPORATED

WHEREAS, the city entered into a purchase agreement with Cargill, Incorporated on June 15, 2015 to sell a vacant industrial-zoned 18.766 acre parcel commonly known as 1509 West Oliver Street; and

WHEREAS, after the city of Owosso has completed its due diligence, recognizing the need to keep a small portion of the original property to contain a portion of the public roadway giving access to the property, the total amount of acreage has changed, therefore changing the total sale price and the legal description; and

WHEREAS, Article II, Section 2.1 of the original purchase agreement is deleted in its entirety and replaced with the following:

"In consideration of Seller's agreement to sell the Property, Cargill agrees to pay to Seller as the full purchase price (the "<u>Purchase Price</u>") for the Property the sum of SIXTY SEVEN THOUSAND EIGHT ONE and NO/100 DOLLARS (\$67,081.00), which sum is calculated at the rate of THREE THOUSAND SEVEN HUNDRED and NO/100 DOLLARS (\$3,700.00) per acre and on the basis of the Property comprising 18.13 acres. The Purchase Price shall be paid by Cargill to Seller in full on the Closing Date by check or by wire transfer of funds to an account designated by Seller."
