#### **PUBLIC HEARINGS**

#### **Skate Park Project Approval & Grant Application**

A public hearing was conducted to receive citizen comment regarding the proposal to construct a new skate park at Grove Holman Park and consider applying for a MDNR Recreation Passport Grant for said improvements.

There were no citizen comments received prior to the meeting.

The following person commented regarding the proposed skate park:

Parks & Recreation Commission Chairman Michael Espich asked for Council's support for the grant application saying it was no time to stop rebuilding the park system in the City.

Mayor Eveleth thanked City staff for their work and the Commission for their passion in seeing this project through to this point.

Whereas, the Council, after due and legal notice, has met and having heard all interested parties, motion by Councilmember Teich that the following resolution approving grant application to the Michigan Department of Natural Resources for a Recreation Passport Grant to assist in the construction of a new skate park be adopted:

#### **RESOLUTION NO. 28-2017**

### TO SEEK A RECREATION PASSPORT GRANT THROUGH THE MICHIGAN DEPARTMENT OF NATURAL RESOURCES

WHEREAS, the Owosso Skate Park is currently located on the corner of Allendale and Gould Street; and

WHEREAS, the park's structures have exceeded their useful life, and regular maintenance cannot effectively address some of the facility's shortcomings; and

WHEREAS, the city of Owosso intends to relocate the skate park to Grove Holman Park, a city owned park within the city of Owosso; and

WHEREAS, the new skate park will provide a recreation space for skaters that is more centrally located as well as increase accessibility; and

WHEREAS, the city of Owosso Parks and Recreation Commission have held several public meetings to engage local youth, skaters and bikers regarding design alternatives and park relocation; and

WHEREAS, the city of Owosso Parks and Recreation Commission has held fundraising events over the last two years for the skate park; and

WHEREAS the city of Owosso city council is publicly and financially committed to carrying out the improvements for a new skate park located at Grove Holman Park; and

WHEREAS, the State of Michigan Department of Natural Resources is accepting Recreation Passport Grant applications for its 2017 funding year for amounts up to \$75,000 for the purpose of "providing public outdoor recreation opportunities and infrastructure to support public outdoor recreation activity".

NOW, THEREFORE, BE IT RESOLVED that the city of Owosso city council commits to funding the capital rehabilitation funding proposal below and further directs staff to complete and submit an application for the 2017 Recreation Passport Grant Program through the Michigan Department of Natural Resources (MDNR).

#### **CITIZEN COMMENTS AND QUESTIONS**

Eddie Urban, 601 Glenwood Avenue, said he would like to see another "talk with a cop" session saying he missed the first one and thought it was a really great idea.

Tom Cook, Friends of the Shiawassee River president, invited the City to join the water trail coalition which hopes to bring communities along the river together to promote the river.

County Commission Dan McMaster updated the Council on recent affairs at the county level. He said a special investigation has been called to look into complaints about the local veterans' affairs office. He also mentioned the recent controversy regarding the selection of voting equipment saying the issue should be resolved in the next couple of weeks. He reassured those present that the issue would have no effect on the upcoming May election.

Mayor Eveleth said he had gone to the Historical Commission strategic planning meeting over the weekend and was excited to see them putting together a plan to move toward an independent organization.

Switching gears the Mayor noted that budget season was upon us and requested everyone bring their calendars to the next meeting to set the annual budget workshops.

At the Mayor's request City Manager Donald D. Crawford gave an update on brush pickup following the wind storm over a week ago.

Councilmember Bailey spoke in support of the local veterans' affairs office saying they helped her mother when no one else could

Councilmember Fox indicated he had received a phone call from a gentleman seeking information on the status of medical marijuana related businesses in Owosso. In light of this phone call he asked that Council set a meeting to talk about the future governance of medical marijuana related businesses. Mr. Fox then expressed his support for the local veterans' affairs office saying they are responsible for some very good things.

Councilmember Bailey announced the first spay/neuter event for 2017 to be held March 30<sup>th</sup> with 60 available spaces. She indicated similar events will be held each month through November. She also thanked the City for allowing the organization to use their facilities to further their mission.

SUBJECT: Chipman Street Resurfacing – Special Assessment Resolution No 3

When deemed necessary, the city conducts a street improvement program. Public streets are selected for inclusion in the program either by citizen initiated petition or by selection of the city. Chipman Street, from South Street to Stewart Street, is proposed by the city for street resurfacing. Property owners are then specially assessed to cover the cost of the proposed improvement. Past practice has been to assess property owners along the street 40% of the proposed benefit and the remaining 60% to the community at large. Each property owner can pay an assessment in one lump sum or in installments over the multi-year period (the period being determined by the amount of the average assessment).

The special assessment process has five steps, each having its own purpose and accompanying resolution.

**Step One/Resolution No. 1** identifies the special assessment district(s), directs the city manager to estimate project costs and the amounts to be specially assessed, and determines the life of the proposed improvements. Resolution No. 1 for the proposed improvement was approved by City Council at its January 3, 2017 meeting.

**Step Two/Resolution No. 2** sets the date for the hearing of necessity on the projects. It directs notices to be sent to each affected property owner detailing the proposed project, notifying them of the public hearing date, and the estimated amount of their assessment. Resolution No. 2 for the proposed improvement was approved by City Council at its March 6, 2017 meeting.

**Step Three/Resolution No. 3** documents the hearing of necessity. This hearing provides affected residents with the opportunity to comment on whether they feel the project is necessary and of the proper scale. After hearing citizen comment on the project the city council has three options: if they agree that the project should proceed as proposed, the district is established and staff is directed to go on with the next steps of the proposed project, including obtaining bids; if they feel the project should go forward, but with some adjustments they may direct staff to make those adjustments and proceed; if they feel the project is not warranted and should not proceed at all they would simply fail to act on Resolution No. 3, effectively stopping the process. City Council is asked to act upon Resolution No. 3 on April 3, 2017 for the proposed improvement.

**Step Four/Resolution No. 4** takes place after the bids are received. Estimated assessment amounts are adjusted if necessary to reflect the actual cost as dictated by the bids received. A second public hearing is set to allow property owners to comment on their particular assessment. Each property owner is sent a second notice containing the date and time of the public hearing and the amount of the proposed assessment for their property.

**Step Five/Resolution No. 5** documents the second public hearing, finalizes the special assessment roll and sets the terms of payment. This public hearing is designed to allow

affected citizens the opportunity to argue whether or not the amount of their assessment is fair and equitable in relation to the benefit they receive from the project. If, after hearing citizen comment, the council decides adjustments need to be made to the assessment roll they may do so. Alternately, if they feel all the assessments are fair and equitable they may pass the resolution as written.

Tonight the council will be holding a public hearing to receive citizen comments regarding the necessity of the proposed project. At the conclusion of the hearing council will consider approval of Resolution No. 3 authorizing the project to proceed. Residents that would be affected by the project have been sent a notification for the public hearing, a description of the work being proposed, and an estimate of the special assessment for their property.





We would like to thank you for the opportunity to submit a proposal for assisting the City in addressing the Sanitary Sewer Administrative Consent Order (ACO).

#### PROJECT UNDERSTANDING

The City of Owosso is currently under an ACO from the Michigan Department of Environmental Quality (MDEQ) due to sanitary sewer overflows (SSOs) within the City's system and at the Wastewater Treatment Plant (WWTP) during wet weather events. Initial investigation has shown that excess flow at the WWTP contributes to the SSOs. Because there are other communities that contribute flows to the WWTP, the overflow issue is a Regional concern and will likely require a Regional solution. Our scope for the ACO assistance includes professional engineering services to assist the City with the following objectives:

- I. Determine the sources of peak wet weather flow by community
- II. Develop the design peak flow reaching the Wastewater Treatment Plant (WWTP) and compare to the WWTP capacity
- III. Develop alternatives and conceptual costs for improvements at the WWTP to handle the design peak flow
- IV. Develop recommendations for the cost allocation methodology for improvements between the communities

#### **SCOPE OF SERVICES**

To meet the objectives listed above, OHM Advisors has broken the project into five Phases, as outlined below. Due to the nature of these services, we are proposing an allowance budget for each of the Phases.

#### PHASE I: LONG TERM FLOW METERING

In order to determine the sources of peak wet weather flow and develop the design peak flow reaching the WWTP, flow metering is necessary. We recommend that the City purchase up to five (5) meters and perform long-term metering. A sixth meter may be purchased at a later date if it is deemed necessary. This will maximize the chances of recording a large rainfall event and provide suitable data to evaluate long-term system performance from Inflow and Infiltration (I/I) removal efforts in the City and tributary communities. The flow metering phase is broken into tasks, listed below.



- Procure up to five (5) flow meters (for the City to own).
- Install and maintain the flow meters for at least one year.
- Collect data from the flow meters.
- Review flow meter data for meter performance and maintenance needs.

#### PHASE II: ANALYSIS AND MODELING

Once the meter data is collected and verified for accuracy, an analysis will be done to determine the flow distribution between communities. Specific work efforts include:

- Import data into H2Ometrics for analysis.
- Analyze large storms to determine peak flows by community. This will help develop improvement alternatives
  and be important input for developing a cost allocation amongst the communities.
- Develop hydrologic flow models for each community (3 new) to develop the design peak flow at the WWTP for each community.

A small allowance was added to the budgeted cost for this phase to allow for development of a hydraulic model of the collection system, if needed.

#### **COMPENSATION**

The above-mentioned services would be performed on Time and Materials basis Not to Exceed those estimates stated below in accordance with the original contract.

#### **FUTURE PHASES**

The following Phases listed are potential future tasks to continue understanding solutions to the regional surcharging problem. OHM Advisors is not asking for authorization on these tasks at this time.

#### PHASE III: CONCEPTUAL ENGINEERING

Once we have an understanding of the flow distribution in the system, we can begin to conceptualize potential improvements. The tasks associated with this are listed below.

- Compare design peak flow to WWTP capacity.
- Develop options for improvements at the WWTP to meet the design peak flow. This may include storage at the WWTP or additional WWTP capacity.



- Develop conceptual improvement plan for potential improvements (GIS map).
- Develop conceptual cost estimates for potential improvements.
- Develop recommendations for cost allocation methodology amongst the stakeholder communities using the flow data collected.

#### PHASE IV: STAKEHOLDER ENGAGEMENT

Throughout the technical analysis of this project, which encompasses the first three phases, OHM Advisors will maintain open communication with the City of Owosso and each stakeholder community. This will include stakeholder and review board meetings to explain the objectives, address stakeholder issues or concerns, present findings, and answer questions. Because the number of meetings may vary, we propose that this task be budgeted as an allowance. For budgeting purposes, it was assumed that OHM Advisors would attend four stakeholder meetings and four review board meetings.

#### PHASE V: REGULATORY SUPPORT

Throughout this project, OHM Advisors expects to assist the City and stakeholders in discussions with the Michigan Department of Environmental Quality (MDEQ). This may include attending meetings with the MDEQ to discuss the objectives of this project, address any issues or concerns the MDEQ may have, present findings, and answer questions. Additionally, we will assist in the annual ACO reporting of this project and assist the City with other MDEQ submittals. Because the number of meetings may vary, we propose that this task be budgeted as an allowance.

#### PHASE VI: ADDITIONAL AS NEEDED SERVICES

This additional as-needed task will be used for items that may arise during the project that were not anticipated at the time this proposal was prepared. These may include items such as additional flow metering and analysis, additional stakeholder meetings beyond what was originally estimated for the allowance, or additional coordination with the MDEQ beyond what was originally estimated for the allowance budget. We will seek authorization from the City prior to incurring effort in the additional services task.

#### **BACKGROUND:**

As part of the Primary Clarifier replacement project, which is expected to commence about July 5, 2017, several project components are also occurring, and in advance of Primary Clarifier rehabilitation. These are:

- Screening Units (one for each Primary Clarifier) recently built under separate contract will be installed in April and placed into service.
- Wash Compactors (one for each Screening Unit) recently built under the same Screening Unit Contract, will be attached to the newly constructed Containment Rooms after completion.
- Demolition of the three lime towers within the WWTP, is required to make room for the Wash Compactor Containment Rooms.

The Screening Units capture inorganic solid material from the Primary Clarifiers, and then transfers this material to a Wash Compactor that compresses the accumulated material to meet or exceed minimum landfill moisture content requirements. #### ARTICLE I - Scope of work

No additional work shall be performed unless a change order is issued by the city.
- (B) The amount paid shall be equitably adjusted to cover changes in the work ordered by the city but not required by the contract documents where there is a written change order.

#### **ARTICLE III – Assignment**

This contract may not be assigned or subcontracted without the written consent of the city.

#### **ARTICLE IV - Choice of law**

This contract shall be construed, governed, and enforced in accordance with the laws of the state of Michigan. By executing this agreement, the contractor and the city agree to a venue in a court of appropriate jurisdiction sitting within Shiawassee County for purposes of any action arising under this contract.

#### **ARTICLE VI - Notice**

All notices given under this contract shall be in writing, and shall be by personal delivery or by certified mail with return receipt requested to the parties at their respective addresses as specified in the contract documents or other address the contractor may specify in writing.

#### **ARTICLE VII - Indemnification**

#### **RECOMMENDATION:**

Authorization to reimburse Joann M. Tilson sewer demand charges paid from March 31, 2010 to present, in the amount of \$1,967.40.

#### **BACKGROUND:**

The property located at 1410 Frederick Street has been vacant from March 31, 2010 through present. In addition, Consumers Energy terminated the electrical power to the property effective March 31, 2010 and remains off to this day.

The property is connected to the city of Owosso sanitary sewer collection system, and has been invoiced quarterly the minimum sewer demand charges as required. Even though not connected to city water, the property has a private drinking water well, which is powered by electricity and has not been in operation since termination of electrical service on March 31, 2010. It is therefore reasonable to conclude that the sanitary sewer collection system was not used from March 31, 2010 through present.

Ms. Joann M. Tilson has provided proof of ownership of the property, and has provided a written statement from Consumers Energy stating that the electrical service to 1410 Frederick Street was terminated on March 31, 2010 and remains terminated to date. The property is listed for sale and is not currently occupied.

This reimbursement in the amount of \$1,967.40 is recommended to be final, without contest after receipt of payment, and is not precedent setting for future claims against the city of Owosso.

#### **FISCAL IMPACTS:**

Funds in the amount of \$1,967.40 will be reimbursed from the sewer revenue account.

**SUBJECT:** Unpaid Utility Billings to be Transferred to Taxes

#### **RECOMMENDATION:**

The Water Department asks that Council please review the list and, if acceptable, approve publication of Notice of Collection by the Clerk's Office.

#### **BACKGROUND:**

In accordance with the Charter, this time each year the Water Department prepares a listing of unpaid water/sewer bills that could be transferred to taxes. The unpaid bill listing is primarily made up of unpaid past due, final water bills, but can include active uncollectible bills from the previous year.

A letter explaining the collection procedure has been sent to each owner along with a copy of the original billing. Any billing that remains unpaid after April 30, 2017 will be added to the 2017 summer real property tax bill with an additional 10% penalty.

If you have any questions, please direct them to Andrea Smith or myself.

#### **FISCAL IMPACTS:**

Theoretically there would be no fiscal impacts as the unpaid charges are transferred to taxes, though in actuality we do experience some losses. As with special assessments for demolition or clean-up costs unpaid utilities liens could potentially fall victim to the tax sale process if the property goes into tax foreclosure, but the chances of this are small.

The USEPA Clean Water Act of 1972 established regulatory and enforcement parameters for water protection. The USEPA Safe Drinking Water Act of 1974 (SDWA) enacted additional regulatory legislation for public health and safety. An amendment to the SDWA in1996 required the public to receive annual Consumer Confidence Reports (CCR), detailing compliance of regulated characteristics of drinking water from municipal sources.

The city of Owosso 2017 CCR is hereby submitted in accordance with the USEPA Clean Water Act. This final report has been reviewed by and approved for publication by the Michigan Department of Environmental Quality.

## 2017 Water Quality Report - City of Owosso Water System

This report covers the drinking water quality for the City of Owosso Water System for the 2016 calendar year. This information is a snapshot of the quality of the water that we provided to you in 2016. Included are details about where your water comes from, what it contains, and how it compares to Environmental Protection Agency (EPA) and state standards.

Your water comes from 6 groundwater wells, each over 80 feet deep. The State performed an assessment of our source water to determine the susceptibility or the relative potential of contamination. The susceptibility rating is on a seven-tiered scale from "very-low" to "very-high" based on geologic sensitivity, well construction, water chemistry and contamination sources. The susceptibility of our source is rated as susceptible.

There are no known or identified significant sources of contamination within the city water supply. Ground Water sources are monitored and protected by an approved Michigan Department of Environmental Quality (MDEQ) Wellhead Protection Program Plan (WHPP), which is designed to (1) ensure safe drinking water to the public, and (2) protect drinking water from potential sources of contamination by following the WHPP program guidelines set forth by the MDEQ.

#### Water Quality Data

The table below lists all the drinking water contaminants that the city detected during the 2016 calendar year. The presence of these contaminants in the water does not necessarily indicate that the water poses a health risk. Unless otherwise noted, the data presented in this table is from testing conducted during January 1 – December 31, 2016. The State of Michigan allows the monitoring of certain contaminants less than once per year because the concentrations of these contaminants are not expected to vary significantly from year to year. The data delineated below is representative of the water quality testing performed during 2016, with some data being more than one year old as approved by the MDEQ.

#### Terms and abbreviations used below:

- <u>Maximum Contaminant Level Goal (MCLG)</u>: The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- <u>Maximum Contaminant Level (MCL)</u>: The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- <u>Maximum Residual Disinfectant Level (MRDL)</u>: The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
- <u>Maximum Residual Disinfectant Level Goal (MRDLG)</u>: The level of a drinking water disinfectant which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
- N/A: Not applicable. ND: Not detectable at testing limit. ppb: Defined as parts per billion or micrograms per liter. ppm: Defined as parts per million or milligrams per liter. pCi/l: Defined as picocuries per liter (a measure of radioactivity).

Information about lead: If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with water service lines and home plumbing. The City of Owosso Water System is responsible for providing high quality drinking water, but cannot control the variety of materials used in household plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Infants and children who drink water containing lead in excess of the action level could experience delays in their physical or mental development. Children could show slight deficits in attention span and learning abilities. Adults who drink this water over many years could develop kidney problems or high blood pressure.

Monitoring and Reporting Requirements: The State of Michigan and the USEPA requires the testing of water on a regular basis to ensure its safety. The city of Owosso has met all mandated monitoring and reporting requirements for 2016.

Water Quality Reporting: The city updates this report annually, and will keep consumers informed of any water quality concerns that may occur throughout the year. Copies of the Water Quality Annual Report are available at City Hall.

Comment and Inquiries: The city invites public participation in decisions that affect drinking water quality. Public comment may be provided at City Hall during regularly scheduled city council meetings, held at 7:30 p.m. on the first and third Mondays of each month.
