Parkinson's Awareness Month

Mayor Eveleth read aloud the following proclamation of the Mayor's Office declaring the month of April 2018 as Parkinson's Awareness Month in the City of Owosso:

A PROCLAMATION OF THE MAYOR'S OFFICE OF THE CITY OF OWOSSO, MICHIGAN PROCLAIMING APRIL 2018 AS PARKINSON'S AWARENESS MONTH IN THE CITY OF OWOSSO

WHEREAS, Parkinson's disease is a chronic, progressive neurological disease that causes motor

system disorders; and

WHEREAS, Parkinson's disease affects nearly 35,000 in the State of Michigan and its prevalence continues to rise significantly with the increasing age of the Baby Boom generation; and

WHEREAS, a local support group, the Owosso Parkinson's Support Group, has been meeting for over twenty-seven years in an effort to provide education, support and fellowship to those

affected by this frustrating disease.

NOW, THEREFORE, I, Christopher T. Eveleth, Mayor of the City of Owosso, Michigan, do hereby proclaim the month of April 2018 as Parkinson's Awareness Month in the City of Owosso, Michigan and do hereby encourage all citizens of this community to acknowledge and support the Owosso Parkinson's Support Group and their activities to inform and serve the citizens of our community because their services make a difference.

PUBLIC HEARINGS

Special Assessment District No. 2018-04 Howard Street from Washington Street to 150' east of Park Street

Prior to the public hearing Utilities Director Glenn M. Chinavare briefly detailed the proposed project saying the street would be fully reconstructed including the installation of new watermain, new storm sewer lines, and new curb and gutter.

A public hearing was conducted to receive citizen comment regarding Resolution No. 3 for proposed Special Assessment District No. 2018-04 for Howard Street from Washington Street to 150' east of Park Street for street reconstruction.

The following person commented prior to the meeting regarding the proposed project:

Rodney Rust, owner of the property between the rail road tracks and Howard Street, via telephone, said he objects to the proposed project for two reasons: 1. his proposed assessment is several times the price he paid for the property; 2. the new curb and gutter would make it impossible for him to continue to use his lot for the purpose in which he purchased it (semi parking).

The following people commented during the meeting regarding the proposed project:

Roger Snyder, representing Rodney Rust, said the property isn't worth the amount that it's being assessed and that if curb and gutter is installed Mr. Rust will be unable to use the property for the purpose in which he purchased it.

Lester Donelson, owner of 515 S. Park Street, said the City has torn up the street, the sidewalk, and his driveway and is now asking him to pay for the repair and that is unfair.

Carl Ludington, owner of 503 S. Washington Street, said he is in favor of the proposed project, the drainage of the area is very poor and this project will fix that problem. He went on to say that he would like to put apartments above his office eventually.

Mayor Eveleth inquired whether curb and gutter would be installed along the north side of the street. City Engineer Randy J. Chesney indicated it would, but it shouldn't interfere with Mr. Rust's use of his property. He went on to say that the purpose of the curb and gutter is to redirect storm water to the storm sewer system and improve the drainage in an area that has had a persistent problem. He said he could work with Mr. Rust to determine where the access points in the curb should be.

In response to Mr. Donelson's comments Utilities Director Chinavare indicated that if City crews damaged the street and/or sidewalk then the City would restore it. He asked that Mr. Donelson contact him to further discuss the issue.

City Engineer Chesney noted that plans for the project include the replacement of driveway approaches and sidewalks at no charge to the property owners.

Mayor Eveleth noted that the purpose of the public hearing this evening was to determine whether the project is necessary and having driven through the area recently he said the project is very necessary and proceeding makes sense.

City Manager Henne instructed the Council that because the property owners placing objections to the project amounted to more than 50% of the cost of the assessment the affirmative vote of at least five members of the Council would be required to move the project forward.

Motion by Councilmember Teich that the following resolution be adopted:

RESOLUTION NO. 38-2018

ESTABLISHING SPECIAL ASSESSMENT DISTRICT NO. 2018-04 HOWARD STREET, FROM WASHINGTON STREET TO 150' EAST OF PARK STREET FOR STREET RECONSTRUCTION

WHEREAS, the City Council, after due and legal notice, has met and having heard all persons to be affected by the proposed public improvement more particularly hereinafter described; and

WHEREAS, the City Council deems it advisable and necessary to proceed with said public improvement as more particularly hereinafter described.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The City Council hereby determines to make and proceed with the following described public improvement and to defray a part or the whole cost, as more particularly hereinafter provided, by special assessment upon the property specially benefited:

HOWARD STREET, A PUBLIC STREET, FROM WASHINGTON STREET TO 150' EAST OF PARK STREET
STREET RECONSTRUCTION

- 2. The City Council hereby approves the plans for the aforesaid public improvement as prepared and presented by the City Manager and determines the estimated cost of said public improvement to be \$311,639.70 and approves said estimated cost and determines that the estimated life of said public improvement is twenty (20) years.
- 3. The City Council determines that of said total estimated cost, the sum of \$56,322.10 be paid by special assessment upon the property specially benefited, as more particularly hereinafter described, and that the sum of \$255,317.60 of said total estimated cost shall be the obligation of the City at large because of benefit to the City at large.
- 4. The City Council hereby designates the following described property as the special assessment district upon which the special assessment shall be levied:

Howard Street, a Public Street, from Washington Street to 150' east of Park Street Street Reconstruction

- 5. The City Assessor shall prepare a special assessment roll including all lots and parcels of land within the special assessment district herein designated, and the Assessor shall assess to each such lot or parcel of land such relative portion of the whole sum to be levied against all lands in the special assessment district as the benefit to such lot or parcel of land bears to the total benefits to all lands in such district.
- 6. When the Assessor shall have completed the assessment roll, he shall file the special assessment roll with the City Clerk for presentation to the City Council.

First Reading & Set Public Hearing – Ordinance Amendment – Chapter 26, Signs. Conduct first reading and set a public hearing for Monday, May 7, 2018 to receive citizen comment on the proposal to amend Chapter 26, Signs, Article IV, General Provisions, Section 26-19, General standards for permitted signs, subsection 1a, Sign setbacks, of the Code of Ordinances of the City of Owosso to reduce the setback requirement of ten (10) feet from any public right-of-way to five (5) feet as follows:

RESOLUTION NO. 39-2018

TO AMEND SECTION 26-19(1)a OF THE CODE OF THE CITY OF OWOSSO TO REDUCE SIGN SETBACKS

WHEREAS, subsection *1a. Sign setbacks*, of Section 26-19, <u>General standards for permitted signs</u>, outlines specific regulations regarding signage and setback requirements; and

WHEREAS, the setback requirements pertaining to public right-of-ways require modification to correct an error made when the ordinance was repealed and replaced in May 2017; and

WHEREAS, the planning commission held a public workshop at their March 26, 2018 regularly scheduled meeting regarding the proposed amendment to Section 26-19, <u>General standards for permitted signs</u>, subsection *1a. Sign setbacks* in which no citizen comments were voiced or received; and

WHEREAS, the planning commission recommends amending Section 26-19 (1) a to correct the error.

NOW THEREFORE BE IT RESOLVED, THAT THE CITY OF OWOSSO ORDAINS:

SECTION 1. AMENDMENT. That subsection *a. Sign setbacks* of Section 26-19(1). <u>General standards</u> for permitted signs of the Owosso City Code be amended to read:

Sec. 26-19. - General standards for permitted signs.

Signs which are permitted as accessory uses serving a commercial or informational purpose may be permitted subject to the requirements of this article; provided, that no such sign shall be erected or altered until approved by the building official/zoning administrator and until a sign permit has been issued pursuant to chapter 26 of the City of Owosso Code of Ordinances.

- (1) Sign setbacks.
 - a. All signs, unless otherwise provided for, shall be set back a minimum of ten feet five (5) feet from any public or private street right-of-way line or access drive in all districts. This distance shall be measured from the nearest edge of the sign, measured at a vertical line perpendicular to the ground to the right-of-way.

SECTION 2. SEVERABILITY. The various sections and provisions of this Ordinance shall be deemed to be severable, and should any section or provision of this Ordinance be declared by any court of competent jurisdiction to be unconstitutional or invalid the same shall not affect the validity of this Ordinance as a whole or any section or provision of this Ordinance other than the section or provision so declared to be unconstitutional or invalid.

SECTION 3. INCONSISTENT ORDINANCES. All ordinances or parts of ordinances inconsistent with the provisions of this Ordinance are repealed.

SECTION 4. PUBLIC HEARING. A public hearing is set for Monday, May 7, 2018 at 7:30 p.m. for the purpose of hearing citizen comment regarding the proposed amendment to Chapter 26, Signs, of the Code of Ordinances of the City of Owosso.

SECTION 4. EFFECTIVE DATE. This amendment shall become effective 20 days after approval.

SECTION 5. AVAILABILITY. This ordinance may be purchased or inspected in the city clerk's office, Monday through Friday between the hours of 9:00 a.m. and 5:00 p.m.

WHEREAS, the City Council has ordered the City Manager to prepare a report for public improvement, more particularly hereinafter described; and

WHEREAS, the City Manager prepared said report and the same has been filed with the City Council as required by the Special Assessment Ordinance of the City of Owosso and the Council has reviewed said report.

Mayor Eveleth inquired whether all the eligible service lines in the City could be replaced should the City receive this grant. Utilities Director Chinavare said he was skeptical that it would, he said he hoped to cover at least 50%-75% of the City if possible.

Councilmember Fox inquired about costs to the customer and whether local contractors would be doing some of the work. Mr. Chinavare indicated there would be no cost to customers with lead or galvanized service lines and local contractors would be utilized to conduct some of the work. He went on to say that City crews will also be working on the project and his goal was to do as much as possible leaving no grant money on the table.

Motion by Councilmember Fox to authorize application to the MDEQ for a Pilot Drinking Water Community Water Supply Grant in the amount of \$1,000,000.00, designate Utilities Director Glenn M. Chinavare and City Manager Donald D. Crawford as the City's authorized representatives for the purposes of the grant should it be awarded, and approve the proposed form of the grant agreement as detailed:

RESOLUTION NO. 52-2018

AUTHORIZING THE APPLICATION FOR A PILOT DRINKING WATER COMMUNITY WATER SUPPLY GRANT AND APPROVAL OF PROPOSED AGREEMENT

WHEREAS, a pilot drinking water community water supply grant program was established with the passing of the supplemental budget of the Department of Environmental Quality ("DEQ"); and

WHEREAS, the pilot drinking water community water supply grant program, administered by the DEQ, provides assistance to municipalities for updating distribution system material inventories and asset management plans to identify lead service lines and galvanized steel service lines, and replacing lead service lines and galvanized steel service lines; and

WHEREAS, it is the determination of the Municipality that, at this time, a grant in the aggregate principal amount not to exceed one million dollars ("Grant") be requested from the DEQ to pay for the above-mentioned undertaking(s); and

WHEREAS, the Municipality shall obtain this Grant by entering into a grant agreement ("Grant Agreement") with the DEQ.

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Utilities Director, a position currently held by Glenn M. Chinavare, and the City Manager, a position currently held by Donald D. Crawford, are designated as the Authorized Representatives for purposes of the Grant Agreement.
- 2. The proposed form of the Grant Agreement between the Municipality and the DEQ is hereby approved and the Authorized Representative(s) is authorized and directed to execute the Grant Agreement with such revisions as are agreed to by the Authorized Representative(s).
- 3. The Authorized Representative(s) is hereby authorized to take any actions necessary to comply with the requirements of the DEQ in connection with the issuance of the Grant, including executing and delivering such other contracts, certificates, documents, instruments, applications and other papers as may be required by the DEQ or as may be otherwise necessary to affect the approval and delivery of the Grant.
- 4. The Municipality acknowledges that the Grant Agreement is a contract between the Municipality and the DEQ.
- 5. All resolutions and parts of resolutions insofar as they conflict with the provisions of this resolution are rescinded.

SUBJECT: Stewart Street Resurfacing – Special Assessment Resolution No 3

When deemed necessary, the city conducts a street improvement program. Public streets are selected for inclusion in the program either by citizen initiated petition or by selection of the city. **Stewart Street, from Cedar Street to Shiawassee Street,** is proposed by the city for street resurfacing. Property owners are then specially assessed to cover the cost of the proposed improvement. Past practice has been to assess property owners along the street 40% of the proposed benefit and the remaining 60% to the community at large. Each property owner can pay an assessment in one lump sum or in installments over the multi-year period (the period being determined by the amount of the average assessment).

The special assessment process has five steps, each having its own purpose and accompanying resolution.

Step One/Resolution No. 1 identifies the special assessment district(s), directs the city manager to estimate project costs and the amounts to be specially assessed, and determines the life of the proposed improvements. Resolution No. 1 for the proposed improvement was approved by City Council at its **September 18, 2017** meeting.

Step Two/Resolution No. 2 sets the date for the hearing of necessity on the projects. It directs notices to be sent to each affected property owner detailing the proposed project, notifying them of the public hearing date, and the estimated amount of their assessment. Resolution No. 2 for the proposed improvement was approved by City Council at its **April 2, 2018** meeting.

Step Three/Resolution No. 3 documents the hearing of necessity. This hearing provides affected residents with the opportunity to comment on whether they feel the project is necessary and of the proper scale. After hearing citizen comment on the project the city council has three options: if they agree that the project should proceed as proposed, the district is established and staff is directed to go on with the next steps of the proposed project, including obtaining bids; if they feel the project should go forward, but with some adjustments they may direct staff to make those adjustments and proceed; if they feel the project is not warranted and should not proceed at all they would simply fail to act on Resolution No. 3, effectively stopping the process. City Council will take comments from the affected residents at its **April 16, 2018** meeting.

Step Four/Resolution No. 4 takes place after the bids are received. Estimated assessment amounts are adjusted if necessary to reflect the actual cost as dictated by the bids received. A second public hearing is set to allow property owners to comment on their particular assessment. Each property owner is sent a second notice containing the date and time of the public hearing and the amount of the proposed assessment for their property.

Step Five/Resolution No. 5 documents the second public hearing, finalizes the special assessment roll and sets the terms of payment. This public hearing is designed to allow affected citizens the opportunity to argue whether or not the amount of their assessment is fair and equitable in relation to the benefit they receive from the project. If, after hearing citizen comment, the council decides adjustments need to be made to the assessment roll they may do so. Alternately, if they feel all the assessments are fair and equitable they may pass the resolution as written.

Tonight the council will be holding a public hearing to receive citizen comments regarding the necessity of the proposed project. At the conclusion of the hearing council will consider approval of Resolution No. 3 authorizing the project to proceed. Residents that would be affected by the project have been sent a notification for the public hearing, a description of the work being proposed, and an estimate of the special assessment for their property.

Staff recommends authorization of Resolution No. 3 for the following district:

Special Assessment District No. 2018-06 – Stewart Street, Public Street, from Cedar Street to Shiawassee Street

RESOLUTION NO.

ESTABLISHING SPECIAL ASSESSMENT DISTRICT NO. 2018-06 STEWART STREET, FROM CEDAR STREET TO SHIAWASSEE STREET FOR STREET RESURFACING

WHEREAS, the City Council, after due and legal notice, has met and (there being no one to be heard regarding / having heard all persons to be affected by) the proposed public improvement more particularly hereinafter described; and

WHEREAS, the City Council deems it advisable and necessary to proceed with said public improvement as more particularly hereinafter described.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The City Council hereby determines to make and proceed with the following described public improvement and to defray a part or the whole cost, as more particularly hereinafter provided, by special assessment upon the property specially benefited:

STEWART STREET, A PUBLIC STREET, FROM CEDAR STREET TO SHIAWASSEE STREET STREET RESURFACING

- 2. The City Council hereby approves the plans for the aforesaid public improvement as prepared and presented by the City Manager and determines the estimated cost of said public improvement to be \$331,305.00 and approves said estimated cost and determines that the estimated life of said public improvement is twenty (20) years.
- The City Council determines that of said total estimated cost, the sum of \$72,902.88 be paid by special assessment upon the property specially benefited, as more particularly hereinafter described.
- 4. The City Council hereby designates the following described property as the special assessment district upon which the special assessment shall be levied:
 - Stewart Street, a Public Street, from Cedar Street to Shiawassee Street Street Resurfacing
- 5. The City Assessor shall prepare a special assessment roll including all lots and parcels of land within the special assessment district herein designated, and the Assessor shall assess to each such lot or parcel of land such relative portion of the whole sum to be levied against all lands in the special assessment district as the benefit to such lot or parcel of land bears to the total benefits to all lands in such district.
- 6. When the Assessor shall have completed the assessment roll, he shall file the special assessment roll with the City Clerk for presentation to the City Council.

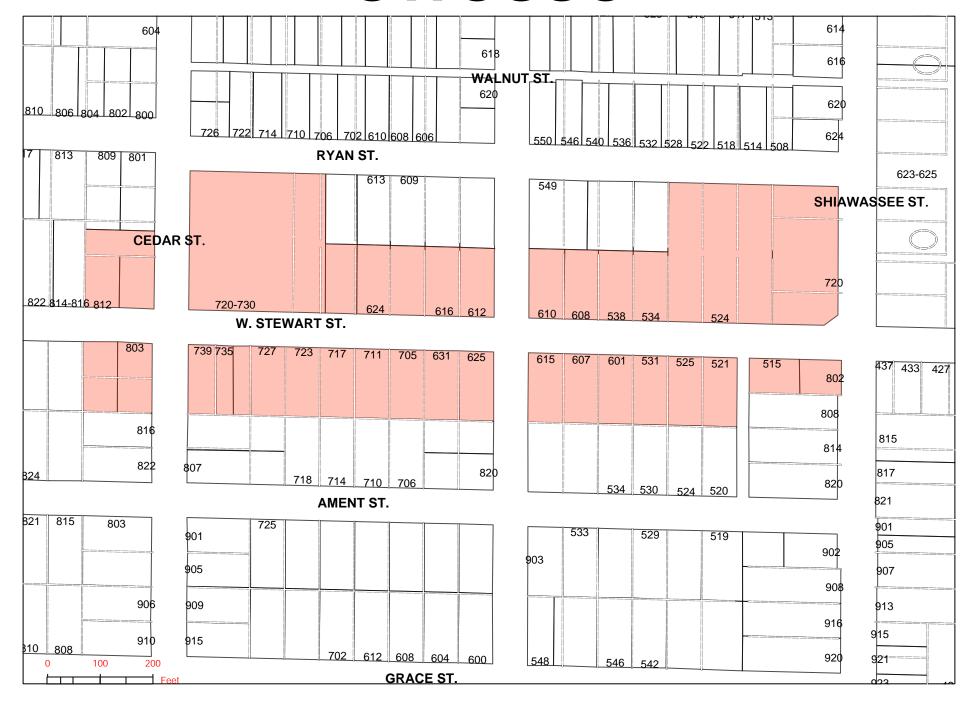

RECOMMENDATION:

Approval of MDOT Cost Agreement No. 18-5039 for the proposed road improvements along McMillan Avenue from Monroe Street southerly 750', along Monroe Street from McMillan Avenue westerly to Gould Street, and along Gould Street from Monroe Street northerly to Highway M-71 (Corunna Avenue).

BACKGROUND:

On June 19, 2017, City Council approved city staff recommendation to make application to MDOT for Transportation Economic Development Funds, Category A (TEDF-A), for the proposed reconstruction of McMillan Avenue from Monroe Street southerly 750', proposed reconstruction of Monroe Street from McMillan Avenue westerly to Gould Street, and proposed resurfacing of Gould Street from Monroe Street northerly to M-71 (Corunna Avenue). The state of Michigan offers these funds explicitly to local agencies for road improvements that support private initiatives such as job creation. Proposed work includes asphalt paving, intersection improvements, storm drainage, concrete curb and gutter, concrete sidewalk and ADA ramps, permanent signing, and pavement markings; altogether with necessary related work (also referred to as 'project'). The City is responsible to design and oversee the project in accordance with MDOT standards. The state agrees to reimburse the city for its share of state funds, in accordance with the Agreement.

FISCAL IMPACTS:

The total estimated cost for this project is \$1,051,280.75 and of that amount, TEDF-A Funds will pay \$325,000.00. The City's estimated share is \$726,280.75. The City will also be responsible for any cost overruns exceeding the estimated cost for the project. Funds for the City's share of cost will be taken from the 2016 Unlimited Obligation Bond Proceeds and other funds as appropriate.

WHEREAS, the City has applied for, and is now approved to receive, state of Michigan Transportation Economic Development Funds towards street improvements that support private initiatives such as job creation within the city of Owosso; and

WHEREAS, after review, city staff recommends approval of MDOT Cost Agreement No. 18-5039 for the proposed reconstruction of McMillan Avenue from Monroe Street southerly 750', proposed reconstruction of Monroe Street from McMillan Avenue westerly to Gould Street, and proposed resurfacing of Gould Street from Monroe Street northerly to M-71 (Corunna Avenue); and

WHEREAS, proposed work will include asphalt paving, intersection improvements, storm drainage, concrete curb and gutter, concrete sidewalk and ADA ramps, permanent signing, and pavement markings; altogether with necessary related work (also referred to as 'project'); and

WHEREAS, the Michigan Department of Transportation requires the city of Owosso adopt a resolution indicating its willingness to participate in the improvements of these streets as set forth in the Agreement.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Owosso, Shiawassee County, Michigan that:

FIRST: The city of Owosso has theretofore determined that it is advisable, necessary and in the

public interest to approve MDOT Agreement No. 18-5039 for the proposed street reconstruction of McMillan Avenue from Monroe Street southerly 750', proposed street reconstruction of Monroe Street from McMillan Avenue westerly to Gould Street, and proposed street resurfacing of Gould Street from Monroe Street northerly to M-71

(Corunna Avenue).

SECOND: That the City of Owosso is willing to participate in the project and cost as illustrated within

said Agreement.

THIRD: That the Mayor and City Clerk are hereby authorized to sign the Agreement as attached.

FOURTH: The City Council hereby directs staff to allocate \$726,280.75 from the 2016 Unlimited

Obligation Bond Proceeds Fund, any other funds as appropriate, and to receive \$325,000.00 from the state of Michigan Transportation Economic Development Fund, for a total of \$1.051,280.75 to fund this project, and directs the City Manager to proceed with

the project, in accordance with the MDOT Contract Agreement.

THIS CONTRACT is made and entered into this date of _______, by and between the MICHIGAN DEPARTMENT OF TRANSPORTATION, hereinafter referred to as the "DEPARTMENT;" and the CITY OF OWOSSO, a Michigan municipal corporation, hereinafter referred to as the "REQUESTING PARTY;" for the purpose of fixing the rights and obligations of the parties in agreeing to the following improvements, in the City of Owosso, Michigan, hereinafter referred to as the "PROJECT" and estimated in detail on EXHIBIT "I," dated January 26, 2018, attached hereto and made a part hereof:

Hot mix asphalt roadway reconstruction work along McMillan Avenue from Monroe Street southerly for approximately 750 feet, along Monroe Street from McMillan Avenue westerly to Gould Street, and along Gould Street from Monroe Street northerly to Highway M-71 (Corunna Avenue); and all together with necessary related work.

WITNESSETH:

WHEREAS, the State of Michigan is hereinafter referred to as the "State;" and

WHEREAS, the PROJECT has been approved for financing in part with funds from the State appropriated to the Transportation Economic Development Fund, hereinafter referred to as "TED FUNDS," qualifies for funding pursuant to PA 231, Section 11(3)(a); Public Act of 1987, as amended, and is categorized as:

CATEGORY "A" FUNDED PROJECT

WHEREAS, the parties hereto have reached an understanding with each other regarding the performance of the PROJECT work and desire to set forth this understanding in the form of a written contract.

NOW, THEREFORE, in consideration of the premises and of the mutual undertakings of the parties and in conformity with applicable law, it is agreed:

- 1. The parties hereto shall undertake and complete the PROJECT in accordance with the terms of this contract.
- 2. The term "PROJECT COST," as herein used, is hereby defined as the cost of the physical construction necessary for the completion of the PROJECT.

The costs incurred by the REQUESTING PARTY for preliminary engineering, construction engineering and inspection, and right-of-way are excluded from the PROJECT COST as defined by this contract.

3. The DEPARTMENT is authorized by the REQUESTING PARTY to perform, at no cost to the PROJECT, such administration of the PROJECT covered by this contract as is necessary to assist the REQUESTING PARTY to qualify for funding. Such administration may include performing such review, legal, financing, any other PROJECT related activities as are necessary to assist the REQUESTING PARTY in meeting applicable State requirements.

The DEPARTMENT shall provide the REQUESTING PARTY with a notice to proceed with the award of the construction contract for the PROJECT.

The DEPARTMENT shall make a final acceptance inspection of the PROJECT as necessary to ensure the PROJECT meets State requirements. Failure to comply with State requirements may result in forfeiture of future distributions of the Michigan Transportation Fund as described in Section 6. No charges will be made by the DEPARTMENT to the PROJECT for any inspection work or construction engineering.

- 4. The REQUESTING PARTY, under the terms of this contract, shall advertise and award the PROJECT work in accordance with the following:
 - A. The REQUESTING PARTY will, at no cost to the DEPARTMENT or the PROJECT, design, or cause to be designed, the PROJECT, and shall accept full responsibility for that design. Any review undertaken by the DEPARTMENT is for its own purposes and is not to nor does it relieve the REQUESTING PARTY of liability for any claims, causes of action or judgments arising out of the design of the PROJECT.
 - B. The REQUESTING PARTY, hereby, certifies to the DEPARTMENT that the plans, specifications, and estimates for the PROJECT have been prepared in compliance with applicable State laws, local ordinances, and State and local standards and regulations.
 - C. The REQUESTING PARTY, hereby, certifies to the DEPARTMENT that the contracting procedures to be followed by the REQUESTING PARTY in connection with the solicitation of the construction contract for the PROJECT shall be based on an open competitive bid process. It is understood that the proposal for the PROJECT shall be publicly advertised and the contract awarded on the basis of the lowest responsive and responsible bid in accordance with applicable State statutes, local ordinances, and State and local regulations.

- (1) The REQUESTING PARTY shall not award the construction contract prior to receipt of a notice to proceed from the DEPARTMENT.
- Upon verification that contractor selection by the REQUESTING PARTY was made in accordance with the terms of this contract and upon receipt of the "Request for Payment" form from the REQUESTING PARTY, the DEPARTMENT will authorize payment to the REQUESTING PARTY for the eligible amount in accordance with Section 5.
- D. The REQUESTING PARTY will, at no cost to the PROJECT or the DEPARTMENT, comply with all applicable State statutes, local ordinances, and State and local regulations, including, but not limited to, those specifically relating to construction contract administration and obtain all permits and approvals with railway companies, utilities, concerned State, Federal, and local agencies, etc., and give appropriate notifications as may be necessary for the performance of work required for the PROJECT.

The REQUESTING PARTY agrees to comply with all applicable requirements of Part 91, Soil Erosion and Sedimentation Control of the Natural Resources and Environmental Protection Act, 1994 PA 451 as amended by 1995 PA 60 and 1996 PA 173, MCL 324.9101 et. seq., for all PROJECT work performed under this contract, and the REQUESTING PARTY shall require its contractors and subcontractors to comply with the same.

- E. All work in connection with the PROJECT shall be performed in conformance with the DEPARTMENT'S current Standard Specifications for Construction, special provisions, and the supplemental specifications and plans pertaining to the PROJECT. All materials furnished and used in the construction of the PROJECT shall conform to the aforesaid specifications. Any changes in the scope of work for the PROJECT will require approval by the DEPARTMENT.
- F. The REQUESTING PARTY shall, at no cost to the PROJECT or to the DEPARTMENT, appoint a project engineer who shall administer the PROJECT and ensure that the plans and specifications are followed, and shall perform or cause to be performed the construction engineering and inspection services necessary for the completion of the PROJECT.

Should the REQUESTING PARTY elect to use consultants for construction engineering and inspection, the REQUESTING PARTY shall provide a full-time project manager employed by the REQUESTING PARTY who shall ensure that the plans and specifications are followed.

- G. The REQUESTING PARTY shall require the contractor who is awarded the contract for the construction of the PROJECT to provide, as a minimum, insurance in the amounts specified in and in accordance with the DEPARTMENT'S current Standard Specifications for Construction, and to:
 - (1) Maintain bodily injury and property damage insurance for the duration of the PROJECT.
 - (2) Provide owner's protective liability insurance naming as insureds the State of Michigan, the Michigan State Transportation Commission, the DEPARTMENT and its officials, agents and employees, the REQUESTING PARTY and any other party with jurisdiction for the roadway being constructed as the PROJECT, and their employees, for the duration of the PROJECT and to provide copies of certificates of insurance to the insureds. It is understood that the DEPARTMENT does not assume either ownership of any portion of the PROJECT or jurisdiction of any REQUESTING PARTY highway as a result of being named as an insured on the owner's protective liability insurance policy.
 - (3) Comply with the requirements of notice of cancellation and reduction of insurance set forth in the current Standard Specifications for Construction and to provide copies of notices and reports prepared to those insured.
- 5. The PROJECT COST shall be met in part by contributions by TED FUNDS. TED FUNDS Category A shall be applied to the eligible items of the PROJECT COST up to an amount not to exceed the lesser of: (1) 39 percent of the approved and responsible low bid amount, or (2) \$325,000. The balance, if any, of the PROJECT COST, after deduction of TED FUNDS, is the sole responsibility of the REQUESTING PARTY.

The REQUESTING PARTY shall be responsible for the payment of all costs and expenses incurred in the performance of PROJECT work.

Based upon the final cost of the PROJECT, the final costs included in the grant, and/or a request by the REQUESTING PARTY, a payment adjustment may be initiated and/or authorized by the DEPARTMENT for eligible items of the PROJECT COST such that the total amount of TED FUNDS does not exceed \$325,000. The grant includes those activities of preliminary

engineering, right-of-way acquisition, construction, and construction engineering related to the grant. The REQUESTING PARTY shall certify all actual costs incurred for work performed under this contract that are eligible for payment with TED FUNDS and will be required to repay any TED FUNDS it received in excess of 39 percent of the total of such costs.

6. The REQUESTING PARTY shall establish and maintain adequate records and accounts relative to the cost of the PROJECT. Said records shall be retained for a period of three (3) years after completion of construction of the PROJECT and shall be available for audit by the DEPARTMENT. In the event of a dispute with regard to allowable expenses or any other issue under this contract, the REQUESTING PARTY shall continue to maintain the records at least until that dispute has been finally decided and the time after all available challenges or appeals of that decision has expired.

The DEPARTMENT, or its representative, may inspect, copy, or audit the records at any reasonable time after giving reasonable notice.

The REQUESTING PARTY, within six (6) months of completion of the PROJECT and payment of all items of PROJECT COST related thereto, shall make a final reporting of construction costs to the DEPARTMENT and certify that the PROJECT has been constructed in accordance with the PROJECT plans, specifications, and construction contract.

In the event that an audit performed by or on behalf of the DEPARTMENT indicates an adjustment to the costs reported under this contract or questions the allowability of an item of expense, the DEPARTMENT shall promptly submit to the REQUESTING PARTY a Notice of Audit Results and a copy of the audit report which may supplement or modify any tentative findings verbally communicated to the REQUESTING PARTY at the completion of an audit.

Within sixty (60) days after the date of the Notice of Audit Results, the REQUESTING PARTY shall: (a) respond in writing to the responsible Bureau or the DEPARTMENT indicating whether or not it concurs with the audit report, (b) clearly explain the nature and basis for any disagreement as to a disallowed item of expense, and (c) submit to the DEPARTMENT a written explanation as to any questioned or no opinion expressed item of expense, hereinafter referred to as the "RESPONSE". The RESPONSE shall be clearly stated and provide any supporting documentation necessary to resolve any disagreement or questioned or no opinion expressed item of expense. Where the documentation is voluminous, the REQUESTING PARTY may supply appropriate excerpts and make alternate arrangements to conveniently and reasonably make that documentation available for review by the DEPARTMENT. The RESPONSE shall refer to and apply the language of the contract. The REQUESTING PARTY agrees that failure to submit a RESPONSE within the sixty (60) day period constitutes agreement with any disallowance of an item of expense and authorizes the DEPARTMENT to finally disallow any items of questioned or no opinion expressed cost.

The DEPARTMENT shall make its decision with regard to any Notice of Audit Results and RESPONSE within one hundred twenty (120) days after the date of the Notice of Audit Results. If the DEPARTMENT determines that an overpayment has been made to the REQUESTING PARTY, the REQUESTING PARTY shall repay that amount to the DEPARTMENT or reach agreement with the DEPARTMENT on a repayment schedule within thirty (30) days after the date of an invoice from the DEPARTMENT. If the REQUESTING PARTY fails to repay the overpayment or reach agreement with the DEPARTMENT on a repayment schedule within the thirty (30) day period, the REQUESTING PARTY agrees that the DEPARTMENT shall deduct all or a portion of the overpayment from any funds then or thereafter payable by the DEPARTMENT to the REOUESTING PARTY under this contract or any other agreement, or payable to the REQUESTING PARTY under the terms of 1951 PA 51, as applicable. Interest will be assessed on any partial payments or repayment schedules based on the unpaid balance at the end of each month until the balance is paid in full. The rate of interest will be based on the Michigan Department of Treasury common cash funds interest earnings. The rate of interest will be reviewed annually by the DEPARTMENT and adjusted as necessary based on the Michigan Department of Treasury common cash funds interest earnings. REQUESTING PARTY expressly consents to this withholding or offsetting of funds under those circumstances, reserving the right to file a lawsuit in the Court of Claims to contest the DEPARTMENT'S decision only as to any item of expense the disallowance of which was disputed by the REQUESTING PARTY in a timely filed RESPONSE.

The REQUESTING PARTY shall comply with the Single Audit Act of 1984, P.L. 998-502 and applicable State laws and regulations relative to audit requirements.

- 7. Upon completion of construction of the PROJECT, the REQUESTING PARTY will cause to be enacted and enforced such ordinances or regulations as may be necessary to prohibit parking in the roadway right-of-way throughout the limits of the PROJECT.
- Resources and Environmental Protection Act, MCL 324.20101 et seq., as amended, (NREPA) and is not aware of and has no reason to believe that the property is a facility as defined in the NREPA; b) the REQUESTING PARTY further certifies that it has completed the tasks required by MCL 324.20126 (3)(h); c) it conducted a visual inspection of property within the existing right of way on which construction is to be performed to determine if any hazardous substances were present; and at sites on which historically were located businesses that involved hazardous substances, it performed a reasonable investigation to determine whether hazardous substances exist. This reasonable investigation should include, at a minimum, contact with local, State and federal environmental agencies to determine if the site has been identified as, or potentially as, a site containing hazardous substances; d) it did not cause or contribute to the release or threat of release of any hazardous substance found within the PROJECT limits.

The REQUESTING PARTY also certifies that, in addition to reporting the presence of any hazardous substances to the Department of Environmental Quality, it has advised the DEPARTMENT of the presence of any and all hazardous substances which the REQUESTING PARTY found within the PROJECT limits, as a result of performing the investigation and visual inspection required herein. The REQUESTING PARTY also certifies that it has been unable to identify any entity who may be liable for the cost of remediation. As a result, the REQUESTING PARTY has included all estimated costs of remediation of such hazardous substances in its estimated cost of construction of the PROJECT.

- 9. If, subsequent to execution of this contract, previously unknown hazardous substances are discovered within the PROJECT limits, which require environmental remediation pursuant to either State or federal law, the REQUESTING PARTY, in addition to reporting that fact to the Department of Environmental Quality, shall immediately notify the DEPARTMENT, both orally and in writing of such discovery. The DEPARTMENT shall consult with the REQUESTING PARTY to determine if it is willing to pay for the cost of remediation and to determine the eligibility, for reimbursement, of the remediation costs. The REQUESTING PARTY shall pay all costs associated with such remediation, including all delay costs of the contractor for the PROJECT. If the REQUESTING PARTY refuses to participate in the cost of remediation, the amount of TED FUNDS the REQUESTING PARTY received from Grants 139.01, 139.02, and 139.03 shall be forfeited back to the DEPARTMENT.
- 10. If State funds administered by the DEPARTMENT are used to pay the cost of remediating any hazardous substances discovered after the execution of this contract and if there is a reasonable likelihood of recovery, the REQUESTING PARTY, in cooperation with the Department of Environmental Quality and the DEPARTMENT, shall make a diligent effort to recover such costs from all other possible entities. If recovery is made, the DEPARTMENT shall be reimbursed from such recovery for the proportionate share of the amount paid by the DEPARTMENT and the DEPARTMENT shall credit such sums to the appropriate funding source.
- 11. The DEPARTMENT'S sole reason for entering into this contract is to enable the REQUESTING PARTY to obtain and use funds provided by the State.

Any and all approvals of, reviews of, and recommendations regarding contracts, agreements, permits, plans, specifications, or documents, of any nature, or any inspections of work by the DEPARTMENT pursuant to the terms of this contract are done to assist the REQUESTING PARTY in meeting program guidelines in order to qualify for available funds. Such approvals, reviews, inspections and recommendations by the DEPARTMENT shall not relieve the REQUESTING PARTY and the local agencies, as applicable, of their ultimate control and shall not be construed as a warranty of their propriety or that the DEPARTMENT is assuming any liability, control or jurisdiction.

The providing of recommendations or advice by the DEPARTMENT does not relieve the REQUESTING PARTY and the local agencies, as applicable, of their exclusive jurisdiction of the highway and responsibility under MCL 691.1402 et seq., as amended.

When providing approvals, reviews and recommendations under this contract, the DEPARTMENT is performing a governmental function, as that term is defined in MCL 691.1401 et seq. as amended, which is incidental to the completion of the PROJECT.

- 12. The DEPARTMENT, by executing this contract, and rendering services pursuant to this contract, has not and does not assume jurisdiction of the highway, described as the PROJECT for purposes of MCL 691.1402 et seq., as amended. Exclusive jurisdiction of such highway for the purposes of MCL 691.1402 et seq., as amended, rest with the REQUESTING PARTY and other local agencies having respective jurisdiction.
- 13. The REQUESTING PARTY shall approve all of the plans and specifications to be used on the PROJECT and shall be deemed to have approved all changes to the plans and specifications when put into effect. It is agreed that ultimate responsibility and control over the PROJECT rests with the REQUESTING PARTY and local agencies, as applicable.
- 14. The REQUESTING PARTY agrees that the costs reported to the DEPARTMENT for this contract will represent only those items that are properly chargeable in accordance with this contract. The REQUESTING PARTY also certifies that it has read the contract terms and has made itself aware of the applicable laws, regulations, and terms of this contract that apply to the reporting of costs incurred under the terms of this contract.
- 15. Each party to this contract will remain responsible for any and all claims arising out of its own acts and/or omissions during the performance of the contract, as provided by this contract or by law. In addition, this is not intended to increase or decrease either party's liability for or immunity from tort claims. This contract is also not intended to nor will it be interpreted as giving either party a right of indemnification, either by contract or by law, for claims arising out of the performance of this contract.
- 16. In connection with the performance of PROJECT work under this contract the parties hereto (hereinafter in Appendix "A" referred to as the "contractor") agree to comply with the State of Michigan provisions for "Prohibition of Discrimination in State Contracts," as set forth in Appendix A, attached hereto and made a part hereof. The parties further covenant that they will comply with the Civil Rights Acts of 1964 being P.L. 88-352, 78 Stat. 241, as amended, being Title 42 U.S.C. Sections 1971, 1975a-1975d, and 2000a-2000h-6, and will require similar covenants on the part of any contractor or subcontractor employed in the performance of this contract.

17. The REQUESTING PARTY and other local agencies, as applicable parties, understand and agree that the highway(s) or street(s) being improved under the terms of this agreement and funded with Transportation Economic Development Funds, shall not be subject to any restriction by local authorities in using certain commercial vehicles on such highway(s) or street(s). Such restrictions are in conflict with the basic concept of the Transportation Economic Development Program and Funding. The REQUESTING PARTY, by signing this agreement, agrees to obtain concurrence from other local governmental agencies within whose jurisdiction or control the highway(s) or street(s) are being improved.

18. This contract shall become binding on the parties hereto and of full force and effect upon the signing thereof by the duly authorized officials for the parties hereto and upon the adoption of the necessary resolution approving said contract and authorizing the signatures thereto of the respective officials of the REQUESTING PARTY, a certified copy of which resolution shall be attached to this contract.

APPENDIX A PROHIBITION OF DISCRIMINATION IN STATE CONTRACTS

In accordance with Public Act 453 of 1976 (Elliott-Larsen Civil Rights Act), the contractor shall not discriminate against an employee or applicant for employment with respect to hire, tenure, treatment, terms, conditions, or privileges of employment or a matter directly or indirectly related to employment because of race, color, religion, national origin, age, sex, height, weight, or marital status. A breach of this covenant will be regarded as a material breach of this contract. Further, in accordance with Public Act 220 of 1976 (Persons with Disabilities Civil Rights Act), as amended by Public Act 478 of 1980, the contractor shall not discriminate against any employee or applicant for employment with respect to hire, tenure, terms, conditions, or privileges of employment or a matter directly or indirectly related to employment because of a disability that is unrelated to the individual's ability to perform the duties of a particular job or position. A breach of the above covenants will be regarded as a material breach of this contract.
- 2. The contractor hereby agrees that any and all subcontracts to this contract, whereby a portion of the work set forth in this contract is to be performed, shall contain a covenant the same as hereinabove set forth in Section 1 of this Appendix.
- 3. The contractor will take affirmative action to ensure that applicants for employment and employees are treated without regard to their race, color, religion, national origin, age, sex, height, weight, marital status, or any disability that is unrelated to the individual's ability to perform the duties of a particular job or position. Such action shall include, but not be limited to, the following: employment; treatment; upgrading; demotion or transfer; recruitment; advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship.
- 4. The contractor shall, in all solicitations or advertisements for employees placed by or on behalf of the contractor, state that all qualified applicants will receive consideration for employment without regard to race, color, religion, national origin, age, sex, height, weight, marital status, or disability that is unrelated to the individual's ability to perform the duties of a particular job or position.
- 5. The contractor or its collective bargaining representative shall send to each labor union or representative of workers with which the contractor has a collective bargaining agreement or other contract or understanding a notice advising such labor union or workers' representative of the contractor's commitments under this Appendix.
- 6. The contractor shall comply with all relevant published rules, regulations, directives, and orders of the Michigan Civil Rights Commission that may be in effect prior to the taking of bids for any individual state project.

- 7. The contractor shall furnish and file compliance reports within such time and upon such forms as provided by the Michigan Civil Rights Commission; said forms may also elicit information as to the practices, policies, program, and employment statistics of each subcontractor, as well as the contractor itself, and said contractor shall permit access to the contractor's books, records, and accounts by the Michigan Civil Rights Commission and/or its agent for the purposes of investigation to ascertain compliance under this contract and relevant rules, regulations, and orders of the Michigan Civil Rights Commission.
- 8. In the event that the Michigan Civil Rights Commission finds, after a hearing held pursuant to its rules, that a contractor has not complied with the contractual obligations under this contract, the Michigan Civil Rights Commission may, as a part of its order based upon such findings, certify said findings to the State Administrative Board of the State of Michigan, which State Administrative Board may order the cancellation of the contract found to have been violated and/or declare the contractor ineligible for future contracts with the state and its political and civil subdivisions, departments, and officers, including the governing boards of institutions of higher education, until the contractor complies with said order of the Michigan Civil Rights Commission. Notice of said declaration of future ineligibility may be given to any or all of the persons with whom the contractor is declared ineligible to contract as a contracting party in future contracts. In any case before the Michigan Civil Rights Commission in which cancellation of an existing contract is a possibility, the contracting agency shall be notified of such possible remedy and shall be given the option by the Michigan Civil Rights Commission to participate in such proceedings.
- 9. The contractor shall include or incorporate by reference, the provisions of the foregoing paragraphs (1) through (8) in every subcontract or purchase order unless exempted by rules, regulations, or orders of the Michigan Civil Rights Commission; all subcontracts and purchase orders will also state that said provisions will be binding upon each subcontractor or supplier.

SUBJECT: Bulk Chemical LimeCure-25

RECOMMENDATION:

Authorization to enter into a purchase agreement with Applied Specialties Incorporated of Avon Lake, Ohio for bulk chemicals necessary for treatment of potable water.

BACKGROUND:

Applied Specialties Incorporated is a sole source provider permitted by the Michigan Department of Environmental Quality, for a Lime softening chemical called LimeCure-25. Request waiver of purchasing policy formal bid requirements in order to initiate immediate procurement upon approval and authorization. The purpose of this chemical is to soften the residual Lime (Lime is used for iron and hardness removal) that accumulates and bonds to metal surfaces during the treatment process.

Annually, the Water Treatment Facility must shut down and clean two clarifier treatment processes, which can take on average two to four weeks for each clarifier. Currently, the residual lime from the water softening process that bonds to the metal surfaces of the center column and mechanical drive equipment must be manually chipped away by hand. This is a confined space, where one operator must be secured with a harness and safety lines, and requires another operator as a safety observer and helper.

The addition of the LimeCure is expected to make possible cleaning of the clarifier equipment by means of power washing. This would result in less man-hours for maintenance, minimize confined space entry time, and minimize the opportunity for personnel injury.

Water staff has recently completed the installation of static mixers/injector equipment on each of the two clarifiers, and are now ready to proceed with the purchase of the Lime softening chemical.

FISCAL IMPACTS:

Estimated \$22,000.00 annual expense. Funded from the Operations & Maintenance Budget account 591-553-743.000.

RESOLUTION AUTHORIZING THE EXECUTION OF A PURCHASE ORDER FOR LIMECURE-25 WITH APPLIED SPECIALTIES INCORPORATED IN ACCORDANCE WITH THE PERMIT REQUIREMENTS AS APPROVED BY THE MICHIGAN DEPARTMENT OF ENVIRONMENTAL QUALITY

WHEREAS, the City of Owosso, Shiawassee County, Michigan, requires LimeCure-25 in bulk deliveries for use in treating municipal drinking water; and

WHEREAS, the Michigan Department of Environmental Quality (MDEQ) has approved the use of LimeCure-25, and it is hereby determined that Applied Specialties Incorporated of Avon Lake, Ohio is the only firm qualified and permitted to provide such product in softening residual Lime used in the potable water treatment process; and

WHEREAS, waiver of the purchasing policy formal Bid requirements is requested, in order to comply with the MDEQ permit requirements, and to initiate procurement upon approval and authorization.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Owosso, Shiawassee County, Michigan that:

Thank you for meeting with me last week to discuss the LimeCure. After going through the tour of your lime feed system with you we determined the LimeCure 25 would be the best application to help with mitigating scale and lime deposit accumulation.

The LimeCure 25 would be fed into the main water line leading to your slaker box. As we discussed, we would have to tap into the line as far away from the slaker box as possible. In the case of your setup that would be approximately six feet away. I also recommend a 1" x 12" static mixer just after where you are able to tap into your water line. This will aid in mixing and getting full efficiency of the LimeCure 25.

The LimeCure 25 will reduce the particle size in the slurry creating more surface area and making your lime more efficient. From this you will see a reduction in scale and deposits and the scaling and deposits you do get will be softer and much more easily removed. This will greatly reduce the down time and man hours needed to clean the system including in your clarifiers. There also may be a reduction in overall lime usage.

This letter is in response to the issuance of Permit W171107 (Permit), issued November 3, 2017. The Permit approves a chemical addition to the treatment process, LimeCure25, therefore, it is necessary to conduct WQP sampling.

WQP sampling consists of a set of samples (at least two samples for each parameter) at least 24 hours apart. The required locations of the WQP sampling are at the Owosso Water Treatment Plant (WTP) plant tap and five distribution sites. A set of WQP samples should be collected prior to the installation of LimeCure25 and after it has been installed. If the WQP results are negatively and significantly impacted by the proposal, then additional lead and copper monitoring will be required.

WQP sampling sets must include the following:

- pH (this must be taken in the field at the time of sampling)
- alkalinity
- calcium
- conductivity
- total and orthophosphate (if applicable)
- water temperature (this must be taken in the field at the time of sampling)
- chloride
- sulfate

SUBJECT: 2017-2018 Budget Amendment

Please find attached a 2017-2018 budget amendment. This amendment is necessary to be compliant with the state's budget act. I'm proposing this amendment earlier than in years' past so that we will have a better comparison between the proposed 2018-2019 budget and the 2017-2018 budget.

This budget amendment includes revenue and expense amendments. When possible I adjust revenue up to cover any additional expenses. Also, I may be preparing one more budget amendment near year end if it looks like we need it.

There are four funds that are being amended at this time. I am listing them below with a summary of why the changes are needed.

General Fund

Revenues are approved by source and each revenue source has been either increased to cover additional expenses or decreased because early estimates suggest revenue will be less than originally budgeted. \$214,941 of prior year's fund balance is being budgeted to cover a transfer to major streets for funding of the 2017 road special assessments. This will provide the general fund with approximately \$14,000 in interest for next year's budget. This is a better return on investment than we are getting elsewhere.

When possible, if one department is budgeted high I will reduce that budget and increase another department to make sure we have enough approved expense in each department. Even if the General Fund is under budget in total, the state requires a report to be filed explaining why any department is over budget; no matter how small the overage is. Therefore I have adjusted any departments that might go over budget and decreased other departments that looked like they were extremely under budget. Below is a listing of the departments being amended and a brief explanation of why:

City Manager – (4,000) budgeted high so reduced to increase departments budgeted to low Finance – 1,500 to cover possible overage for wage allocations and new accountant Assessing – 23,000 to cover retiring assessor payouts and pension contribution estimated too low City Attorney – 7,500 to cover possible overages Clerk – 24,000 to cover pension contributions estimated too low Human Resources – (9,000) contractual services budgeted high

Treasury – 4,800 possible overages for new department structuring Information Technology – (19,000) contractual services budgeted high Building/Grounds – 75,000 for unbudgeted carpet/flooring restoration and reallocate wages General Administration – 7,400 to cover possible overages in bad debt from large ambulance write-off Police – (40,000) to reallocate janitorial wage/benefits to building & grounds and wages budgeted high Fire – (10,000) to reallocate janitorial wages to building and grounds Building & Safety – (12,000) for contractual services budgeted high Parking – (6,000) budgeted high so reduced to increase departments budgeted to low Community Development – (7,000) for contractual services budgeted high Parks – 82,000 for matching grant expense that was not budgeted (\$45,000 added to revenue budget) Transfers Out – 252,534 for transfer to major roads to cover 2017 road special assessment funding Other Financing –Fund Balance (117,717) to balance budget amendment

Major Streets Fund

Revenue is being adjusted for a federal grant that will not be received until next year, a transfer in from the General Fund for the financing of the 2017 special assessments and a transfer in from the Capital Improvement Streets Fund of bond proceeds used for 2017-2018 road improvement projects. In the original budget street improvements were budgeted to come out of the Capital Improvement Streets Fund, but after the budget was approved MDOT was contacted and required the street improvement to be accounted for in Major and Local Street Funds. Therefore, an amendment was required to move the budget from one fund to another.

Expense is being amended to comply with MDOT's requirement above.

CDBG Revolving Loan Fund

An unbudgeted transfer out of this fund to Façade fund to support a downtown façade program will be made, which required an increase to expense which is being funded through prior years' fund balance

Capital Improvement Streets Fund

This is an amendment to account for the cost of the road improvement projects in the Major and Local Street Funds, and to reduce revenue because bond proceeds were received in 2016-2017; not as budgeted in 2017-2018.

RECOMMENDATION:

Recommend approval of a 2017-2018 budget amendment resolution

CITY OF OWOSSO ADOPTION OF AMENDED 2017-2018 BUDGET

WHEREAS, the City Council of Owosso has adopted The General Appropriations Act Budget for 2017-2018 by Resolution, and

WHEREAS, Section 9 of the General Appropriations Act requires a departmental budget which stipulates that no transfers of departmental appropriations shall be made without prior approval of the Council, and

WHEREAS, MCL 141.437 states that the local legislative body of the local unit shall amend the general appropriations act as soon as it becomes apparent that a deviation from the original general appropriations act is necessary, and

WHEREAS, the Finance Director has made recommendations that include proposals for measures necessary to provide revenues sufficient to meet expenditures of the fund or both, and

WHEREAS, the City Council of Owosso has determined these changes in the 2017-2018 Owosso Budget (Act) is needed and necessary to monitor the financial operations of the City and to ensure the appropriations do not exceed the expenditures;

NOW THEREFORE BE IT RESOLVED that the City Council of Owosso hereby adopts the amended revenues and expenditures listed below to be reflected in the 2017-2018 Amended Annual Budget (Act).

SUBJECT: Revenue and Expense Financial Reports for March 2018

Please find attached the March revenue and expense financial reports.

General Fund

Revenue

Year to date revenues were \$5,814,000 as of the end of March. The City has earned 78% of its budget, and completed 75% of the fiscal year. As we approach the end of the fiscal year, you will begin to see the difference between the budget and actual get smaller.

Expenditures

Year to date expenses were \$5,376,075 as of the end of March. The City has spent 73% of its budget, and completed 75% of the fiscal year. Most departments are spending below or at budget. A few departments are slightly over mostly due to timing of payments. Below are explanations for departments that are well over budget.

 Clerk's department is over budget because the school election expenses were not budgeted, but will be reimbursed by the school system. A budget amendment will be done to insure the appropriation is in the budgeted expenses.

- Building and Grounds are over budget because of the restoration of the floors and the replacement of carpet; neither was budgeted. A budget amendment will be done to make sure these appropriations are in the budget.
- General Administration had a larger bad debt expense from ambulance billing that anticipated

Major and Local Streets

Year to date revenues will be lower than budgeted throughout the year for these funds. The state pays gas and weight tax (the major revenue source for these funds) two month in arrears.

Originally the road construction projects were budgeted in the Capital Improvement Streets Fund. A budget amendment will be made to transfer the budget to major and local streets where the expenses are recorded.

Historical Commission

The City contributes \$33,000 to this fund to cover part of wages and any maintenance expenses for the castle. All other expense will be covered by either rental income for the Gould House or from donations. The City has pledged to pay for the cost to restore several paintings. In the past the restoration costs were paid as they were incurred as a transfer from the General Fund. However, going forward these expenses will be paid directly from the General Fund; as they are assets of the City not the Historical Commission. There is no effect on the Historical Commission due to this change, as the restoration was not budgeted.

At year end, a review of the General Fund transfer compared to the approved wages, and maintenance expense is performed and the General Fund transfer is either increased or decreased.

Sewer/Water/Wastewater Funds

Revenues

Year to date revenues will almost always be lower than budgeted throughout the year, as billing is done quarterly and always billed in arrears.

Sewer/Water/Wastewater Funds- Continued

Expenditures

Sewer and Waste Water Funds are spending below budget. The Water Fund is spending higher than budget because the automatic meter reading equipment is being expensed between last fiscal year and the current fiscal year. However, the funding of the project was received last year. Therefore, previous year's fund balance will be used to offset the cost in the current fiscal year.

Fleet Fund

The Fleet Fund is spending below budget because only a small amount of capital purchases have been made.

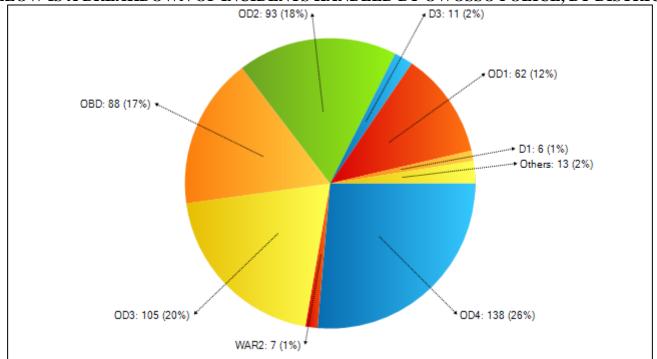

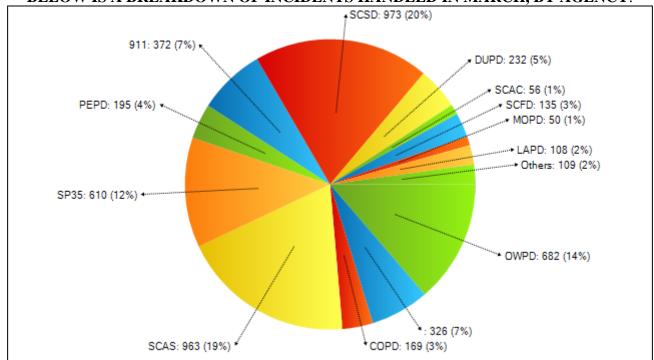

The board agreed to continue the discussion at the next OHC meeting.

- 1. <u>Draft ordinance language for Medical Marihuana Facilities Licensing. Look at proposed</u> ordinance language and discuss.
 - A revised draft from the February 2018 meeting was discussed.
 - All special use permit language has been removed
 - City Attorney Scott Gould presented his recommendations:
 - Sec. 1001 add Further, the city does not intend that permitting and regulation under this chapter to be construed as a finding that such facilities comply with any law.
 - Sec. 1004 add If the application is for a grower's license, the maximum number of plants that the applicant intends to grow will be included.
 - Sec. 1004 add The License requirement in this chapter applies to all facilities whether operated for a profit or not for profit.
 - Sec. 1005 add Applications for renewal or amendment of existing permits shall be reviewed and granted or denied before applications for new permits are considered.
 - Sec. 1007 add D. A license issued under this chapter may be suspended or revoked for any of the following violations:
 - (1) Any person required to be named on the permit application is convicted of or found responsible for violating any provision of this chapter;
 - (2) A permit application contains any misrepresentation or omission of any material fact, or false or misleading information, or the applicant has provided the city with any other false or misleading information related to the facility;
 - (3) Any person required to be named on the permit application is convicted of a crime which, if it had occurred prior to submittal of the application, could have been cause for denial of the permit application;
 - (4) Marihuana is dispensed on the business premises in violation of this chapter or any other applicable state or local law, rule or regulation;

- (5) The facility is operated or is operating in violation of the specifications of the permit application, any conditions of approval by the city or any other applicable state or local law, rule or regulation.
- (6) The city, the county, or any other governmental entity with jurisdiction, has closed the facility temporarily or permanently or has issued any sanction for failure to comply with health and safety provisions of this chapter or other applicable state or local laws related to public health and safety.
- (7) The facility is determined by the city to have become a public nuisance.
- (8) The facility's state operating license has been suspended or revoked.
- Discussion held regarding adding the word alcohol to Other Activities
- Add to Provisioning Centers A new application for a provisioning center, or a request to transfer location of an existing license, may be denied if the proposed location is within 200 feet of a school. The City may waive the school provision if the school does not file an objection to the proposed license. If the school does file an objection, the City shall hold a hearing before making a decision on the issuance of the license.
- Discussion about measuring distance. Agreed to keep what is in the draft.
- Accepting applications need a process. Discussion on the first round of applications. Set a 30 day deadline to submit and then the 4 applicants would be chosen by a lottery (for provisioning centers only). The State does the heavy work on backgrounds and qualifications of applicants. Applicant would pay \$5,000 up front and if don't make lottery, they would receive \$2,500 back. If a license is vacated, do another lottery.
- A rough draft will be completed with the new changes and presented at the April 23, 2018 Public Hearing.
- 2. <u>Master Plan updates review process</u>. <u>Discuss the timeline and implementation strategy</u> necessary to update the current mast plan.
 - An update guide has been provided by the MEDC.
 - Planning commission members are asked to review the current Master Plan and using the review table on page 7 (from MEDC guide) make recommendations to update the Master Plan.
 - The planning commission will review sections at upcoming meetings and hopefully by September they can start the public hearing process.

COMMISSIONER/PUBLIC COMMENT:

Hillary Dulany spoke about the selection process. Does not feel the lottery is fair. Other ways to make selections. Hire an outside service to do the criteria selection.

Chuck Senatore states there is a risk with the lottery system. How are applicants going to know the lottery system is fair – just throw everyone in a hat? It would have to be in public viewing.

At this time, additional discussion about the lottery system was held. It would have to be in a public setting/meeting, just like the opening of bids process is. The City is concerned of liability and doing the selection process by criteria, numbering system, etc. Legal opinion is the lottery system has the lowest liability factor.

Mark Hanna spoke about those applicants with experience and how the lotto could exclude them.
