#### 1) DESIGN

#### **WAY-FINDING SIGNS:**

Signs have been fixed and Agnew Graphics is currently completing insert. A January installation date is foreseeable.

#### **BIKE RACKS**

Five bike racks are complete and ready to install. Installation will take place in the spring.

#### STREETSCAPE IMPROVMENTS

The committee is putting together a plan to present to the city to partner in making downtown hardscape improvements starting this summer. Committee chairman Gilbert suggested setting up a meeting with city officials after the first of the year to discuss a partnership and further delineate hardscape/soft-scape responsibilities.

#### 2) ECONOMIC RESTRUCTURING

Committee chairman Omer indicated they had met the last month. They spent most of the meeting discussing the DDA legislation that was going before the State House & Senate and ways to get information to stakeholders (email, phone calls, etc.)

#### 3) ORGANIZATION

Executive Director Adams indicated that the committee did not meet last month. Mr. Adams stated that he would like to explore the restructuring of the committee during the January, 20<sup>th</sup> Board Retreat.

#### 4) PROMOTION

Executive Director Adams indicated that Glow Owosso was a huge success. Over 5,000 people were estimated to be in attendance. The Gun Run had 140 runners and the parade had 34 floats. Mr. Adams stated that a few businesses had all-time records in sales that night as well. Mayor Evelyth stated that the Ice Queen competition raised \$38,000 for local charities. Mr. Adams stated that the Glow committee raised over \$10,000 during the 2016 calendar year for the Glow program.
