Gould House Inventory: The Commission discussed the items in the Gould House. Motion by Commissioner Little to move the Curwood relevant items, including the Ivan Conger binders to Curwood Castle. Motion supported by Commissioner Hooper. Passed by voice vote.

FINANCIAL REVIEW AND DISCUSSION:

Amy Fuller provided the most recent revenue and expense report and reported that a window had been broken on the Paymaster Building. DPW repaired it and suggested the Commission paint the building this spring.

Denice Grace shared the October financials for Curwood Castle.

PUBLIC COMMENT PERIOD

Rebecca McClear spoke about the Gould House. She requested the Commission put off listing the house on the public market for 6 months to give potential nonprofit organizations time to formulate a plan to purchase the house for public use, below market value, with all of the contents.
