Zoning Districts – Residential districts will go from 5 down to 3 and Business districts will go from 4 down to 3. We are keeping Office district, Industrial districts and Conservation open space district.

Landscape standards and Lighting standards are additional chapters. Signs were under the general ordinance but now added to the Zoning ordinance.
