RE: City Redistricting Plan

Reapportionment / Redistricting Process

Every ten years, after the results of the decennial census are reported, the country undergoes the reapportionment/redistricting process. This process begins at the federal level and filters down through the state and local levels, ultimately resulting in the redrawing of election precincts to accommodate changes in the population over the past ten years. The "process" itself is actually the combination of several tasks, each handled by a different group of people.

At the Federal Level...

Reapportionment happens at the federal level and is the process by which the number of Congressional seats that are held by each state is determined. Keep in mind, this simply lays out the number of Congressional seats each state will have. The boundaries for each Congressional territory are determined at the state level.

At the State Level...

After completion of the reapportionment process, each state sets out, using its own individual laws and rules, to determine how the state's Congressional allotment will be divided among its citizens. For the first time ever the state of Michigan will be utilizing the Michigan Independent Citizens Redistricting Commission (MICRC) to undertake this task, as well as to redraw the district maps for the state senate and the state legislature. A series of proposed maps by the MICRC were available for public comment through December 27, 2021. The Commission voted on final maps December 28, 2021. Since that time a lawsuit has been filed demanding the Commission start over, paying more attention to minority representation. Hopefully, the State Supreme Court will rule on the suit quickly.

The City's new districts would be as follows:

District Type	Current District #	New District #
Congressional	4	7
State Senate	24	28
State House	85	71

At the Local Level...

Moving down to the county level, county commissioner districts are determined by each county's respective County Apportionment Commission. The rules and criteria for establishing commission districts are enshrined in state law and must take into account the maps proposed/established by the MICRC. Districts need to be equal in population as much as possible and not divide local jurisdictions unless absolutely necessary. The Shiawassee County Apportionment Commission adopted their final maps on October 7, 2021.

At the same time these activities are taking place at the state and county levels, Michigan Election Law requires local election commissions to divide their respective municipalities into election precincts to facilitate the conduct of elections.

What We Need To Do...

Our role in the larger process is to examine precinct boundaries as they are currently drawn and determine if any changes are warranted to keep elections running smoothly. To do that we need to know the criteria for forming precincts and what, if anything, has changed since the last census:

Precinct Definition

The following two excerpts of Michigan's Election Law define the criteria for precincts:

MCL 168.661(3) defines a precinct as an area wholly contained within a municipality's borders, which does not split districts (if at all possible), and does not exceed 2,999 registered voters.

MCL 168.654a further defines election precincts:

- (1) An election precinct under this act must be composed as nearly as practicable of compact and contiguous territory and must have clearly defined and clearly observable boundaries.
- (2) As used in this section, "clearly observable boundaries" includes 1 or more of the following:
 - (a) A named road or street.
 - (b) A road or highway that is part of the federal, state primary, or state secondary road system.
 - (c) A river, stream, or drainage feature that is 40 feet or more in width.
 - (d) A natural or constructed permanent physical feature that is shown on an official county, city, or township map issued by the department of transportation or a United States Geological Survey topographical map.

- (e) An apartment building, a dormitory, or other permanent multiple-unit housing structure.
- (f) Any line or demarcation that meets the requirements of and is recognized by the United States Census Bureau.

What Has Changed

- 1. The City of Owosso continues to see a slow decline in its population, from 16,038 in 2000; to 15,194 in 2010; to 14,714 in 2020.
- The boundaries for County Commission Districts 1 & 2 have been adjusted by the County Apportionment Commission to make them closer in size to one another. (County Commission Districts are required to be as close to equal in size as possible.)
- 3. It looks as if the City's Federal Congressional District, State Senate District, and State House District will all be changing. I've reviewed all of the approved maps and the City of Owosso is entirely within the boundaries of each of the three different districts, so we don't have to worry about adjusting our precinct lines to match any of the new districts when they are adopted.

Using the criteria and changes listed above I have put together two redistricting plans for your consideration.

Plan #1 – makes as few changes to the current precinct configuration as possible; it should be noted that the boundaries of Precinct 1-1 and Precinct 2-1 must be changed to reflect the changes made to County Commission Districts 1 and 2 in order to avoid a split precinct (voters were moved from District 1 to District 2 to make them more equal in size).

Plan #2 – makes the changes noted in Plan #1 with an additional change shifting voters from Precinct 2-3 to Precinct 2-4 in an attempt to make all City precincts closer in size to one another. (Equal size is not a requirement when establishing precincts. It just seemed strange to have such a large variation in precinct size.)

I had originally planned on presenting three plans, with the third plan reducing the number of precincts in County Commission District 2 from 4 to 3. But I discovered there really wasn't a good way to split the area up and still maintain clearly observable boundaries. The redrawn precincts had residents living across the street from a polling location travelling a dozen blocks to their assigned polling location. Last and most importantly, dividing District 2 into 3 precincts would make those three precincts significantly larger than they are now. With only 2 polling locations between the 3 precincts two of them would have to share one location and I'm unsure if one location could adequately handle that many voters.

Precinct Labels

Traditionally, the City of Owosso has labeled its precincts using a two-digit system. The first digit would signify the County Commissioner District, and the second would simply differentiate one precinct from another. For example Precinct 2-4, is the 4th City precinct located within County Commissioner District 2. The Bureau of Elections has been pestering us for years to change our precinct labels to remove the hyphen, something about the hyphen being difficult for the voter database to handle. I'm sincerely disappointed the state is asking us to do this as I

think our current labeling scheme provides an extremely accurate description of each precinct (that and I have to have all new signage created for each precinct). But since we are already going to be sending all of our registered voters a new information card now would be the time to change the precinct labels to something the state prefers. I thought about simply removing the hyphen, but I feel the resulting label would be misleading. Instead I'm recommending a simple 1-6 numbering scheme.



Eventual Results

The precincts approved by the Election Commission in the coming weeks will serve as the precinct configuration for the City for the next 10 years – barring any crazy changes in the population during that time.

Each registered voter in the City will receive a new Voter Information Card containing their new Congressional, State Senate & State House districts as well as their new polling location if it is changed. Since all registered voters in the state will receive a new voter information card and there are only a select number of companies that are authorized to print information cards it is important that we try to make a decision sooner rather than later.




Shiawassee County District Map




Shiawassee County Reapportionment Plan 2021

District 2 - population 9,675




